

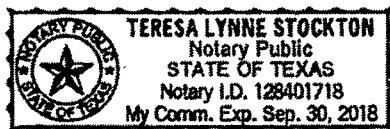


Before me, the undersigned notary, on this day personally appeared Bill Brown, the affiant, whose identity is known to me. After I administered an oath, affiant testified as follows:

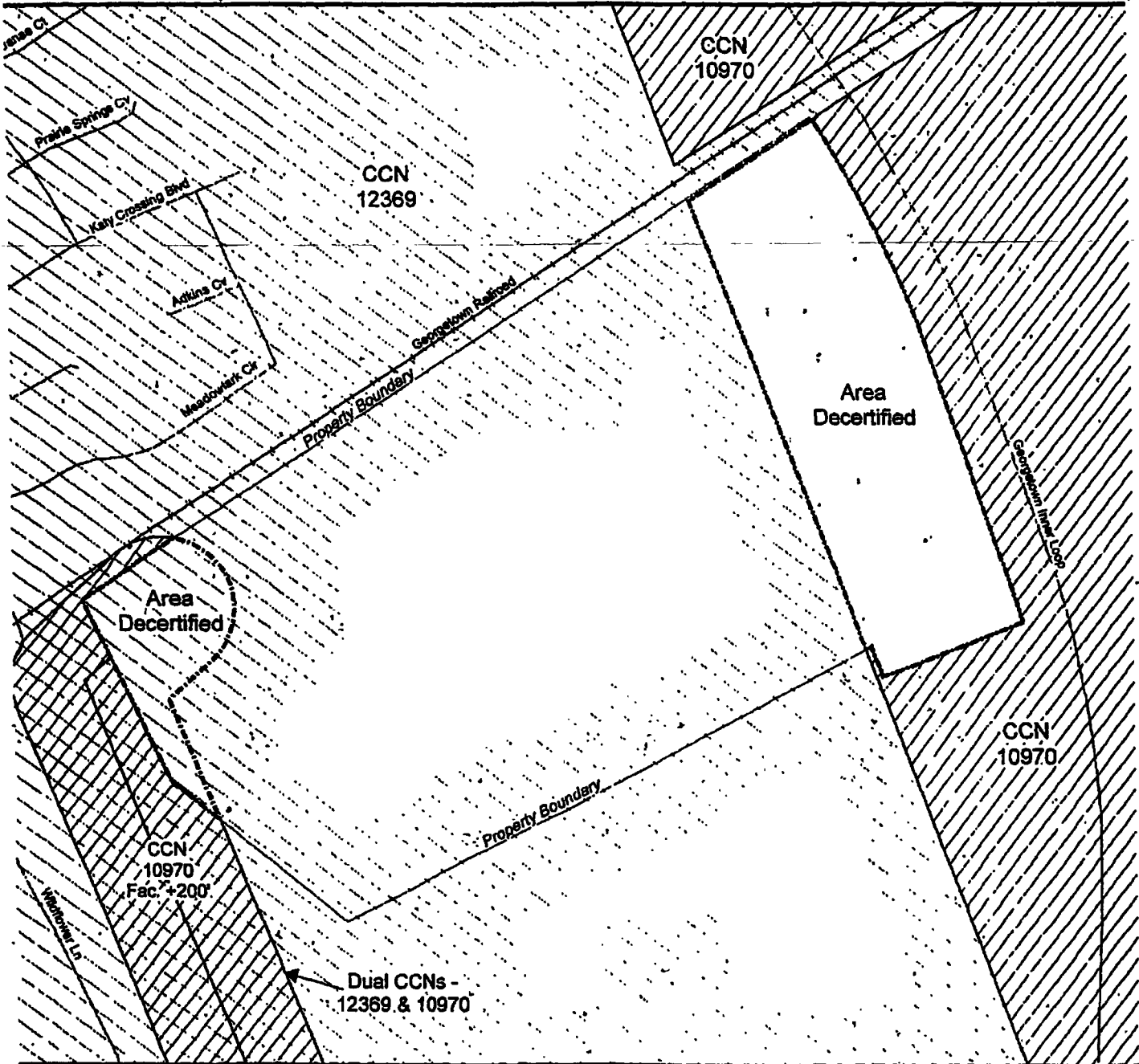
### Certificate of Convenience and Necessity No. 10970

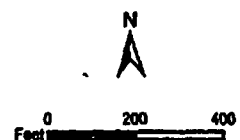
