



### COMMISSION STAFF'S SUPPLEMENTAL RECOMMENDATION

**COMES NOW** the Staff (Staff) of the Public Utility Commission of Texas (Commission), representing the public interest and files this Commission Staff's Supplemental Recommendation. In support thereof, Staff shows the following:

#### I. BACKGROUND

On January 5, 2017, H-M-W Special Utility District (HMWSUD) filed a petition to amend water certificate of convenience and necessity (CCN) No. 10342 and to decertify a portion of CCN No. 10342 in Montgomery County. In Order No. 9, issued November 14, 2017, HMWSUD was ordered to file amended mapping data by November 29, 2017 and Staff was ordered to file a recommendation on that mapping data by December 13, 2017. This pleading is therefore timely filed.

#### II. RECOMMENDATION

Staff has been in discussions with HMWSUD regarding their continued negotiations with neighboring utilities concerning overlapping boundaries. HMWSUD has advised Staff that they are having difficulties contacting an overlapped district, and request 30 additional days to reach a resolution. Staff has no objection to this extension, and, if it is granted, requests HMWSUD be given a deadline of January 12, 2017 for filing supplemental mapping data or a status report, and requests Staff be given a deadline of January 26, 2018 for a supplemental recommendation.

#### III. CONCLUSION

Staff respectfully requests the issuance of an order consistent with this recommendation.
