COMMISSION STAFF'S STATUS REPORT AND REQUEST FOR AMENDED PROCEDURAL SCHEDULE

COMES NOW the Staff (Staff) of the Public Utility Commission of Texas (Commission), representing the public interest, and files this Status Report and Request for Amended Procedural Schedule. In support thereof, Staff shows the following:

I. BACKGROUND

On January 5, 2017, H-M-W Special Utility District (HMWSUD) filed a petition to amend water certificate of convenience and necessity (CCN) No. 10342 and to decertify a portion of CCN No. 10342 in Montgomery County. In Order No.11, issued February 5, 2018, Staff was ordered to file a final recommendation on the application by April 6, 2018. Staff files this status report in lieu of a final recommendation.

II. STATUS REPORT

After reviewing the filing of Primewood Investments, LP, filed on April 2, 2018, Staff recommends that a new final map be issued for consent that includes the recent change to HMWSUD's service area from Docket No. 47918, approved at the March 29, 2018 Open Meeting. In addition, HMWSUD has informed Staff that it plans on submitting minor changes in the requested boundaries to remove overlap with an adjacent utility. Staff therefore requests that the remaining deadlines in this case be adjusted as follows:
