## COMMISSION STAFF'S RECOMMENDATION ON SUFFICIENCY OF APPLICATION

**COMES NOW** the Staff (Staff) of the Public Utility Commission of Texas (Commission), representing the public interest, and files this Recommendation on Sufficiency and Procedural Schedule. In support thereof, Staff shows the following:

#### I. BACKGROUND

On January 5, 2017, H-M-W Special Utility District (HMWSUD) filed a petition to amend water certificate of convenience and necessity (CCN) No. 10342 and to decertify a portion of CCN No. 10342 in Montgomery County. In Order No. 1, issued January 9, 2017, Staff was ordered to file a recommendation on the administrative completeness of the application by February 6, 2017. Staff and HMWSUD (the Parties) were also ordered to propose a procedural schedule. This pleading is therefore timely filed.

#### II. RECOMMENDATION ON ADMINISTRATIVE SUFFICIENCY

Staff has reviewed HMWSUD's application and recommends it be found sufficient for filing, as supported by the attached memorandum of Fred Bednarski of the Water Utilities Division (Attachment A). The Applicant should be ordered to provide notice and proof of that notice using the forms (Attachment B) and in the manner detailed in the attached memorandum.

Staff also recommends that the applicant provide the documents listed in the attached memorandum for Staff's technical review, and that the style of the docket be amended to read, "APPLICATION OF H-M-W SPECIAL UTILITY DISTRICT TO AMEND A WATER CERTIFICATE OF CONVENIENCE AND NECESSITY IN MONTGOMERY COUNTY."

### III. JOINT PROPOSED PROCEDURAL SCHEDULE

Staff recommends the application be found administratively complete. Staff therefore proposes the following procedural schedule, to which HMWSUD has agreed:

On January 05, 2017, the H-M-W Special Utility District (Applicant or H-M-W SUD) filed an application to amend its water Certificate of Convenience and Necessity (CCN) No. 10342 in Montgomery County pursuant to 16 Tex. Admin. Code §§ 24.8 and 24.102 - 24.106 (TAC) and Tex. Water Code § 13.246(c) (TWC). Specifically, the Applicant is seeking to amend its CCN service area boundary by incorporating uncertificated areas and by decertifying portions of neighboring utilities' CCN service area boundaries.

Staff has reviewed the information filed by the Applicant and recommends that the application be found administratively complete and sufficient for filing. Staff also recommends the following:

- 1) The Applicant be ordered to provide correct notice of the application to the following:
  - a) any districts, utilities, and cities within two (2) miles of the proposed service area;
  - b) the county judge of each county and each groundwater conservation district that is wholly or partly included in the proposed area to be certified;
  - c) each city with an extraterritorial jurisdiction (ETJ) that is wholly or partly included in the proposed area to be certified;
  - d) landowners who own a tract of land that is at least 25 acres and is wholly or partly located in the proposed area to be certified. The landowner information may be obtained from the county appraisal district tax rolls for the county or counties in which the proposed CCN is located; and
  - e) publish notice once each week for two (2) consecutive weeks in a newspaper of general circulation in Montgomery County.

- 3) The Applicant must include a copy of a map showing the proposed service areas with the individual notices to neighboring utilities, other affected parties and each landowner. It is the Applicant's burden to provide an accurate map delineating both the proposed water and water service areas with each individual notice. Information related to districts, including addresses, can be obtained by the Applicant from the TCEQ web site located at <a href="http://www14.tceq.texas.gov/iwud/">http://www14.tceq.texas.gov/iwud/</a>.

Staff recommends that the Applicant file a copy of the actual notice and map issued, along with signed affidavits indicating that the notice was given. It is recommended that the Applicant use the attached notices and affidavits to meet these requirements.

In order for Staff to complete the technical review of the application, the Applicant should file a written response addressing the items listed below.

#### Overlap of City Limits

The requested area overlaps the City of Stagecoach (M6, M13) and the City of Tomball (M14) city limits. The Applicant must provide written consent from each city allowing H-M-W SUD to serve in the overlapping area.

#### Overlap of CCN Boundaries

The requested area overlaps the CCN holders listed below. The Applicant must provide written consent from each CCN holder agreeing to decertify the overlapping area.

- a) Aqua Texas Inc (CCN No. 11157 and CCN No. 13203) overlaps M1, M8, M10, M11, M12, M13, M15, M16
- b) Cypresswood Estates (CCN No. 12498) overlaps M15
- c) Johnston Water Utility LLC (CCN No. 12788) overlaps M3, M4, M5, M9
- d) Nerro Supply Investors LLC (CCN No. 10336) overlaps M3, M4
- e) Pinehurst Decker Prairie WSC (CCN No. 11768) overlaps M3, M4, M6, M7, M13, M14
- f) Quadvest LP (CCN No. 11612) overlaps M7, M13
- g) South Central Water Company (CCN No. 13061) overlaps M6

#### Financial

- The Applicant must provide an electronic copy of H-M-W SUD's most recent audited financial statements.
- The Applicant must provide an electronic copy of H-M-W SUD's updated water supply contract with a new expiration date.

#### **Technical**

 The Applicant must provide an updated Existing System Information table to include area M7.
