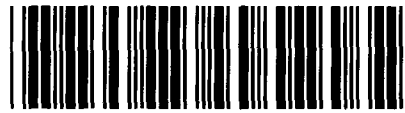

This Order addresses the parties' motion to admit evidence into this proceeding. The items listed below are admitted into evidence in the record of this proceeding.


