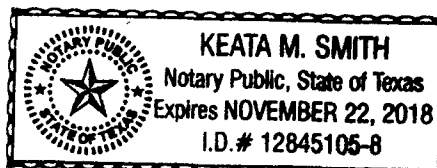

has submitted an application with, the Public Utility Commission of Texas (Commission) to Purchase a portion of water facilities and to transfer a portion of water service area under CCN No. 11438 in Orange County, Texas from:

Vidor, Texas 77670-0389The sale is scheduled to take place as approved by the Commission (V.T.C.A., Water Code § 13.301). The transaction and the transfer of the CCN includes the following subdivision: Cherry Hill Subdivision.The area subject to this transaction is located approximately 2.41 miles West of downtown City of Bridge City, Texas, and is generally bounded on the north by Willoughby Street; on the East by Nelson Street; on the south by F.M. Highway 1442; and on the West by Spooner Street.The total proposed area for the water CCN being requested includes approximately 23 acres and 31 current customers.

This transaction will have the following effect on the current customers' rates and services:

Rates will change for Cherry Hill Subdivision customers to match the City of Bridge City rate structure. You may request a public hearing. A request for a public hearing Must be in writing and include: (1) your name, mailing address, and daytime telephone number; (2) the applicant's name, docket number or another recognizable reference to this application; (3) the statement, "I/we request a public hearing"; (4) a brief description of how you or the persons you represent would be adversely affected by the granting of the application for a CCN; and (5) your proposed adjustment to the application which would satisfy your concerns and cause you to withdraw your request for a hearing.

within thirty (30) days from the date of this publication of notice. A public hearing will be held only if a legally sufficient hearing request is received or if the Commission on its own motion requests a hearing. Only those individuals who submit a written hearing request will receive notice if a hearing is scheduled.

If a valid public hearing is requested, the Commission will forward the application to the State Office of Administrative Hearings (SOAH) for a hearing. If no settlement is reached and an evidentiary hearing is held, SOAH will submit a recommendation to the Commission for final decision. An evidentiary hearing is a legal proceeding 'similar to a civil trial in state district court.
