#### COMMISSION STAFF'S SECOND SUPPLEMENTAL RECOMMENDATION ON ADMINISTRATIVE COMPLETENESS

**COMES NOW** the Staff of the Public Utility Commission of Texas (Staff), representing the public interest, and files this Second Supplemental Recommendation on Administrative Completeness in response to Order No. 3 and would show the following:

#### I. **BACKGROUND**

On January 27, 2017, the City of Fort Worth filed an application to amend its water Certificate of Convenience and Necessity (CCN) No. 12311 in Tarrant County, Texas and decertify a portion of Johnson County Special Utility District's (Johnson County SUD) water CCN No. 10081. Specifically, Fort Worth seeks to add an area of approximately 84 acres that contains no current customers to its CCN. Fort Worth supplemented its application on April 25 and May 18, 2017.

On April 27, 2017, Order No. 3 was issued, establishing a deadline of May 26, 2017 for Staff to file a recommendation on administrative completeness. This pleading is therefore timely filed.

#### II. ADMINISTRATIVE COMPLETENESS

As detailed in the attached memorandum from Jolie Mathis-in-the Commission's Water Utility Regulation Division, Staff has reviewed the application as supplemented and recommends that it be found administratively complete and accepted for filing. Staff further recommends that Fort Worth be directed to publish notice of the application once each week for two consecutive

weeks in a newspaper of general circulation in Tarrant County and provide notice of the application to the following:

- a) any districts, utilities, and cities within two miles of the requested area;
- b) the county judge of each county and each groundwater conservation district that is wholly or partly included in the requested area to be certified;
- c) each city with an extraterritorial jurisdiction (ETJ) that is wholly or partly included in the requested area to be certified;
- d) Aqua Texas Inc;
- e) the City of Burleson;
- f) the City of Crowley;
- g) Johnson County SUD;
- h) the Northern Trinity Groundwater Conservation District;
- i) the Tarrant Regional Water District;
- j) the Trinity River Authority of Texas; and
- k) the Tarrant County Judge.

Staff further recommends that Fort Worth be directed to include a map showing the requested area with the individual notices to neighboring utilities and other affected parties. Staff also recommends that Fort Worth be directed to use the attached notice forms to provide notice and to provide proof of notice by filing a copy of the actual notice and map provided along with executed copies of the attached affidavits attesting to the provision of notice.

#### III. PROCEDURAL SCHEDULE

Staff recommends the application be found administratively complete. Staff therefore proposes the following procedural schedule:

District's Certificate of Convenience and Necessity in Tarrant County

On January 27, 2017, the City of Fort Worth (Applicant) filed with the Public Utility Commission of Texas (Commission) an application to amend its water Certificate of Convenience and Necessity (CCN) No. 12311 and to decertify a portion of Johnson County Special Utility District (SUD)'s water CCN No. 10081 in Tarrant County, Texas pursuant to Texas Water Code Ann. (TWC), §§ 13.242 to 13.250 and 13.254 and 16 Tex. Admin Code (TAC) §§ 24.101 to 24.107 and 24.113.

A Staff review finds the additional maps and digital mapping data filed by the Applicant on April 25, 2017 and May 18, 2017, are sufficient in the required mapping information. Therefore, Staff recommends that the application be deemed sufficient for filing and found administratively complete. Staff further recommends the Applicant be ordered to do the following:

- 1) Provide notice of the application to the following:
  - a) any districts, utilities, and cities within two (2) miles of the requested area;
  - b) the county judge of each county and each groundwater conservation district that is wholly or partly included in the requested area to be certified;
  - c) each city with an extraterritorial jurisdiction (ETJ) that is wholly or partly included in the requested area to be certified; and
  - d) publish notice once each week for two (2) consecutive weeks in a newspaper of general circulation in Tarrant County.
- 2) Provide correct notice of the application to the following entities:
  - Aqua Texas Inc (CCN No. 13201)
  - City of Burleson (CCN No. 10906)
  - City of Crowley (CCN No. 10984)
  - Johnson County SUD (CCN No. 10081)
  - Northern Trinity Groundwater Conservation District
  - Tarrant Regional Water District
  - Trinity River Authority of Texas
  - Tarrant County Judge

3) Include copy of a map showing the requested area with the individual notices to neighboring utilities and other affected parties. It is the Applicant's burden to provide an accurate map delineating the requested area with each individual notice. Information related to districts including addresses can be obtained from the TCEQ's web site located at <a href="http://www14.tceq.texas.gov/iwud/">http://www14.tceq.texas.gov/iwud/</a>.

By July 12, 2017, the Applicant should file a copy of the actual notice and map issued, along with signed affidavits indicating that the notice was given. It is recommended that the Applicant use the attached notices and affidavits to meet these requirements.


