JOINT REQUEST FOR EXTENSION

COMES NOW the Staff of the Public Utility Commission of Texas (Staff), representing the public interest, and the City of Fort Worth and file this Request for Extension in response to Order No. 6 and would show the following:

I. BACKGROUND

On January 27, 2017, the City of Fort Worth (Fort Worth or Applicant) filed an application to amend its water Certificate of Convenience and Necessity (CCN) No. 12311 in Tarrant County, Texas and decertify a portion of Johnson County Special Utility District's (Johnson County SUD) water CCN No. 10081. Specifically, Fort Worth seeks to add an area of approximately 84 acres that contains no current customers to its CCN. Fort Worth supplemented its application on April 25 and May 18, 2017.

On August 8, 2017, Order No. 6 was issued, establishing a deadline of October 13, 2017, for Staff to file a final recommendation on the application. This extension request is therefore timely filed.

II. EXTENSION REQUEST

Staff timely provided final maps, certificates, and consent forms to Fort Worth on September 22, 2017, for review and consent. Fort Worth reviewed the documents and mailed completed consent forms for filing. However, Fort Worth's filing appears to have been delayed or lost in the mail and has not arrived at the Commission, and Fort Worth has resent the completed consent forms. Due to the delay in transit of the completed consent forms, the parties jointly

request that good cause be found under 16 Texas Administrative Code § 22.4(b) for a one-week extension to the remaining deadlines in this docket.

III. REVISED PROCEDURAL SCHEDULE

The parties request a one-week extension to the remaining deadlines in this docket, which would result in the following revised procedural schedule if granted:

Event	Date
Deadline for Staff to file a final recommendation on the Application	October 20, 2017
Deadline for parties to file joint proposed findings of fact and conclusions of law	October 27, 2017

IV. CONCLUSION

For the reasons stated above, the parties request that a one-week extension be granted for the remaining deadlines in this proceeding and that the resulting revised procedural schedule proposed above be adopted.
