The area wherein Cash SUD wants to expand will come through and disturb lines that belong to the City of Cumby, Texas CCN area and will disrupt service to our customers.

Cumby, Texas received a request from landowners in that area to supply water to them. The City of Cumby, Texas is in the process of preparing an application to extend their CCN to include the area within Cash SUD's requested expansion area.

5. Your proposed adjustment to the application which would satisfy your concerns and cause you to withdraw your request for a hearing.

The City's proposed adjustment could only come after a more detailed rendition of the area wherein Cash SUD intends to run its lines and the parties to whom the service is intended. The request is to service an 8 acre area within a much larger service area. To lock-in a CCN for that large of an area with no mention of what happens to those located outside the 8 acres as well as how the City's lines within that area will be addressed makes it almost impossible to propose an adjustment. The requested area map, which is attached to the notice, does not give much detail as to where the lines will be located and exactly what areas they intend to provide water. Does it include the rest stops only? Is it available for others in the area, and at what cost, if any? Will easements need to be sought and if so, from whom? Where are the lines going to be run and what disruption, if any, will this have for the City of Cumby? How long will it take for Cash to install the lines and what disruption will this have for the City and its citizens? The request is too vague and incomplete for the City of Cumby to propose an adjustment at this point. If the Notice and included drawings were amended and some of the areas of concern were addressed and memorialized by Cash, the City of Cumby could at that time decide as to whether or not withdraw this request for a hearing and could possibly negotiate to support this amendment.
