STATEMENT UNDER SECTION 4 OF THE PROTECTIVE ORDER DESIGNATING CONFIDENTIAL AND HIGHLY SENSITIVE PROTECTED MATERIALS

Therefore, the material provided in this response is exempt from public disclosure pursuant to Sections 552.101, 552.104 and/or 552.110 of the Public Information Act as confidential information, as well as by PURA Section 17.004.
