COMMISSION STAFF'S SUPPLEMENTAL RECOMMENDATION ON ADMINISTRATIVE COMPLETENESS AND PROPOSED NOTICE

COMES NOW the Staff of the Public Utility Commission of Texas (Staff), representing the public interest, and in response to Order No. 10, files this Supplemental Recommendation on Administrative Completeness and Proposed Notice. Staff recommends that the application be deemed sufficient for further review. In support thereof, Staff shows the following:

I. BACKGROUND

On February 6, 2017, the City of Princeton (Princeton) filed an application to amend water Certificate of Convenience and Necessity (CCN) No. 13195 and sewer CCN No. 21057 and to decertify a portion of Altoga Water Supple Corporation (Altoga) in Collin County. Although Princeton initially sought to decertify a portion of Altoga's water CCN No. 12580, Altoga's CCN service area is being transferred to North Collin Special Utility District in Docket No. 46452 and CCN No. 12580 will be cancelled.

On February 21, 2018, Order No. 10 was issued establishing a deadline of February 22, 2018, for Staff to file a supplemental recommendation on the administrative completeness of the application, the sufficiency of the proposed notice, and to propose a procedural schedule. Therefore, this pleading is timely filed.

II. **ADMINISTRATIVE COMPLETENESS**

As further detailed in the attached memorandum of Greg Charles of the Commission's Water Utility Regulation Division, Staff has reviewed the application and recommends that it be found administratively complete. As further detailed in the attached memorandum, Staff recommends that Princeton be directed to provide notice of the application to the following:

1

- a. cities, districts, and neighboring retail public utilities providing the same utility service whose corporate boundaries or certificated service area are located within two miles from the outer boundary of the requested area;
- b. the county judge of each county that is wholly or partially included in the requested area;
- c. each groundwater conservation district that is wholly or partially included in the requested area; and
- d. affected customers; and
- e. publish notice once a week for two (2) consecutive weeks in a newspaper of general circulation in Collin County.

Provide correct notice of the application to the following entities:

- City of Lowry Crossing
- City of McKinney (CCN Nos. 10194 & 20071)
- City of Melissa (CCN Nos. 11482 & 20975)
- City of New Hope
- Collin County Judge
- Milligan WSC (CCN No. 10188)
- North Collin SUD (CCN No. 11035)
- North Texas Groundwater Conservation District
- North Texas MWD
- Verona WSC (CCN No. 10184)
- Windmill Estates Water (CCN No. 11645)

Provide an accurate map delineating the requested service area with each individual notice to neighboring utilities, other affected parties, and customers. Information related to districts including addresses can be obtained by the Princeton from the TCEQ web site located at <u>http://www14.tceq.texas.gov/iwud/</u>.

Within 30 days of the date of the notice, file in the docket a map and copy of notice along with an affidavit specifying every person and entity to whom notice was provided, the date that the notice was provided, and the publisher's affidavit for proof of newspaper publication. It is recommended that the Princeton use the attached notices and affidavits to meet these requirements.

Staff recommends that the applicant be ordered to wait to file notice until the transfer of

Altoga's CCN to North Collin Special Utility District is completed.

III. PROCEDURAL SCHEDULE

Staff recommends the application be found administratively complete. Staff therefore proposes the following procedural schedule:

Deadline for Staff to file a recommendation on sufficiency of notice	Within 10 days of Princeton filing proof of completed notice with the Commission
Deadline to intervene	30 days after notice is issued

IV. CONCLUSION

For the reasons detailed above, Staff recommends that the application be found administratively complete, that Princeton be directed to provide notice as detailed above and in the attached memorandum, and that the procedural schedule proposed above be adopted.

Subject:Docket No. 46835: Application of City of Princeton to Amend a Water and Sewer Certificate
of Convenience and Necessity and to Decertify a Portion of Altoga Water Supply
Corporation's Water Certificate of Convenience and Necessity in Collin County

On February 6, 2017, the City of Princeton ("Applicant" or "City") filed an application to its amend water Certificate of Convenience and Necessity (CCN) No. 13195 and sewer CCN No. 21057 in Collin County, Texas, pursuant to Texas Water Code (TWC) §§ 13.242-.250 and 16 Tex. Admin. Code (TAC) §§ 24.101-.107. Although the Applicant initially sought to decertify a portion of Altoga Water Supply Corporation's (Altoga WSC) water CCN No. 12580, Altoga's CCN service area is being transferred to North Collin Special Utility District in Docket No. 46452 and CCN No. 12580 will be cancelled. Therefore, this application will no longer reference Altoga WSC's decertification.

Staff has reviewed the Applicant's supplemental information filed on October 18, 2017, October 25, 2017, and January 18, 2018, and recommends the application be deemed administratively complete and sufficient for filing. Staff also recommends the Applicant be ordered to do the following:

- 1) Provide notice of the application to the following:
 - a) any districts, utilities, and cities within two (2) miles of the proposed area;
 - b) the county judge of each county and each groundwater conservation district that is wholly or partly included in the proposed area to be certified;
 - c) each city with an extraterritorial jurisdiction (ETJ) that is wholly or partly included in the proposed area to be certified; and
 - d) landowners who own a tract of land that is at least 25 acres and is wholly or partly located in the proposed area to be certified. The landowner information may be obtained from the county appraisal district tax rolls for the county or counties in which the proposed CCN is located; and
 - e) publish notice once each week for two (2) consecutive weeks in a newspaper of general circulation in Collin County.

If an evidentiary hearing is held, it will be a legal proceeding similar to a civil trial in state district court.

If you are a landowner with a tract of land at least 25 acres or more, that is partially or wholly located within the proposed service area, you may request to be excluded from the proposed service area (or "opt out") by providing written notice to the Commission within (30) days from the date that notice was provided by the applicant. All requests to opt out of the requested service area must include a large scale map and a metes and bounds description of the tract of land.
