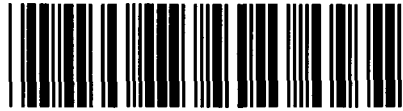

**CITY OF PRINCETON'S AGREED  
MOTION FOR EXTENSION OF DEADLINE**

COMES NOW the City of Princeton, Texas ("City" or "Princeton") and files this Agreed Motion for Extension of Deadline.

Order No. 11, issued February 23, 2018, requires Princeton to file with the Commission signed affidavits that notice has been given to affected parties and publish in the newspaper. Commission staff requested that notice occur after the transfer of the Altoga WSC was completed. Princeton agreed. As a result, the City was delayed in publishing and mailing the notices. Publication of notices are set to occur on April 5, 2018, and April 12, 2018, with mailed notices being sent as well. Thus, the City hereby needs additional time have the publisher's affidavits returned.

Princeton has worked with PUC Staff and they have agreed to extend the deadline for Princeton to file with the PUC signed affidavits that notice has been given to affected parties and publish in the newspaper by an additional three weeks to April 27, 2018. Princeton respectfully requests a modification of the procedural schedule in this matter accordingly.
