**NOTICE OF RULE 11 AGREEMENT**

COMES NOW the City of Princeton, Texas ("City" or "Princeton") and files this Notice of Rule 11 Agreement.

Order No. 11 in this docket set a May 23, 2018, deadline for parties to intervene in this docket. North Collin Special Utility District and Altoga Water Supply Corporation (collectively, "Intervening Parties") through common counsel filed a *Request for Contested Case Hearing and Motion to Intervene* ("Motion to Intervene") on May 23, 2018, but served the City on May 22, 2018. Pursuant to PUC Rule 22.78, the City's response to the Motion to Intervene is May 30, 2018. The City and the Intervening Parties are working on a settlement that will, if agreed to, obviate the need for a referral to the State Office of Administrative Hearings.

Thus, the City, the Intervening Parties, and the Staff of the Public Utility Commission have agreed that the City can delay its response to the Intervening Parties' Motion to Intervene for one calendar week to June 6, 2018. The PUC Staff requested that its deadline to provide final maps, certificates, and tariffs (if applicable) to City for review and consent be delayed by one week. The City agrees to this request, but did not consult with the Intervening Parties on this request prior to filing this Notice.
