NOTICE OF RULE 11 AGREEMENT

COMES NOW the City of Princeton, Texas ("City" or "Princeton") and files this Notice of Rule 11 Agreement.

Order No. 11 in this docket set a May 23, 2018, deadline for parties to intervene in this docket. North Collin Special Utility District and Altoga Water Supple Corporation (collectively, "Intervening Parties") through common counsel filed a *Request for Contested Case Hearing and Motion to Intervene* ("Motion to Intervene") on May 23, 2018, but served the City on May 22, 2018. Pursuant to PUC Rule 22.78, the City's response to the Motion to Intervene is May 30, 2018. The City is working on a map that may obviate the need for a referral to the State Office of Administrative Hearings.

Thus, the City seeks to delay its response to the Intervening Parties' Motion to Intervene to June 28, 2018. The PUC Staff's deadline to provide final maps, certificates, and tariffs (if applicable) to City for review and consent will be delayed by a like time period. Intervening Cities and PUC Staff do not oppose the delay.
