# JOINT MOTION TO AMEND APPLICATION, WITHDRAW PROTEST AND ACKNOWLEDGE RECEIPT OF NOTICE

COMES NOW the Parties and files this Motion to Amend Application, Withdraw Protest and Acknowledge Receipt of Notice. The Parties would respectfully show as follows:

#### I. INTRODUCTION

The City of Princeton ("City"), North Collin Special Utility District ("North Collin") and Altoga Water Supply Agreement ("Altoga") settled their differences which resolved the issues in the instant docket and PUC Docket No. 46452. After notice of the instant docket, North Collin and Altoga sought to intervene in this docket on May 23, 2018. The Parties sought to work out their differences before a ruling on the Motions to Intervene. The Parties hereto express their agreement and seek remand of the Application to the PUC Staff for processing.

#### II. AMENDMENT TO THE APPLICATION

The City hereby seeks to amend its water CCN application to reflect the boundaries contained in Exhibit A. The City's sewer CCN application remains unchanged. Exhibit A contains the appropriate maps and a disk with the shape files for the Application. The City hereby requests that the application be remanded for processing as an uncontested application.

#### III. WITHDRAWAL OF MOTION TO INTERVENE

Due to the amendment of the water CCN application by the City described above, North Collin and Altoga hereby withdraw their Motions to Intervene and no longer seek party status in

the instant docket. Neither North Collin nor Altoga seek further participation in this docket.

#### IV. NOTICE

The City mailed notice of the instant Application to Altoga on May 23, 2018, as shown in Exhibit B. Altoga hereby acknowledges receipt of the notice and waives the need for any further notice of this docket.

#### V. PUC STAFF POSITION

After review, PUC Staff does not oppose the relief requested herein.

# VI. CONCLUSION AND PRAYER

The Parties respectfully requests that:

- (1) The City's Application be amended consistent with this pleading;
- (2) The City's Application be returned to the PUC staff for processing as an uncontested application;
- (3) North Collin and Altoga's Motions to Intervene are hereby withdrawn; and
- (4) Acknowledge Altoga's receipt of notice.





# Notice to Neighboring Systems, Cities and Landowners

NOTICE OF APPLICATION TO AMEND CERTIFICATES OF CONVENIENCE AND NECESSITY (CCN) FOR THE PROVISION OF WATER AND SEWER SERVICES IN COLLIN COUNTY, TEXAS

To: Altoga WSC

The City of Princeton filed an application with the Public Utility Commission of Texas to amend its Certificate of Convenience and Necessity (CCN) Nos. 13195 and 21057 for the provision of water and sewer service in Collin County.

The requested water and sewer areas are located approximately between 2 and 6 miles north of downtown Princeton, Texas, and is generally bounded on the north by <u>CR 471</u>; on the east by <u>CR500 and CR 494</u>; on the south by <u>Monte Carlo Blvd</u>; and on the west by <u>CR 409</u>, <u>FM 1827</u>, and <u>CR 406</u>. The requested water service area includes approximately <u>2633</u> acres. The requested sewer service area includes approximately <u>1636</u> acres.

#### See enclosed map showing the requested area.

Persons who wish to intervene in the proceeding or comment upon action sought should contact the Public Utility Commission, P.O. Box 13326, Austin, Texas 78711-3326, or call the Public Utility Commission at (512) 936-7120 or (888) 782-8477. Hearing- and speech-impaired individuals with text telephones (TTY) may contact the commission at (512) 936-7136. The deadline for intervention in the proceeding is (30 days from the mailing or publication of notice, whichever occurs later, unless otherwise provided by the presiding officer). You must send a letter requesting intervention to the commission which is received by that date.

If a public hearing is requested, the Commission will not issue the CCN and will forward the application to the State Office of Administrative Hearings (SOAH) for a hearing. If no settlement is reached and an evidentiary hearing is held, SOAH will submit a recommendation to the Commission for final decision. If an evidentiary hearing is held, it will be a legal proceeding similar to a civil trial in state district court.

If you are a landowner with a tract of land at least 25 acres or more, that is partially or wholly located within the proposed service area, you may request to be excluded from the proposed service area (or "opt out") by providing written notice to the Commission within (30) days from the date that notice was provided by the applicant. All requests to opt out of the requested service area must include a large scale map and a metes and bounds description of the tract of land.

Persons who meet the requirements to opt out, and wish to request this option should file the required documents with the:

A copy of the request to opt out of the proposed area must also be sent to the applicant. Staff may request additional information regarding your request.
