COMES NOW the City of Princeton ("Princeton" or "City") and files this Submission of Revised CCN Map. Princeton would respectfully show as follows:

I. INTRODUCTION

On April 30, 2018, and July 17, 2018, Ms. Suzy Kemp filed a request to opt out of Princeton's proposed CCN service area in the instant docket. Ms. Kemp's property is located within the Princeton's proposed sewer CCN service area, but not the proposed water CCN. Princeton hereby submits the appropriate maps that reflect the removal of Ms. Kemp's property from Princeton's proposed sewer CCN.

II. AMENDMENT TO THE APPLICATION

The City hereby seeks to amend its sewer CCN application to reflect the service area boundaries contained in Exhibit A. The City's water CCN application is unchanged by this filing. Exhibit A contains the appropriate maps and a disk with the shape files for Princeton's proposed sewer CCN.

III. CONCLUSION AND PRAYER

The City respectfully requests that:

- (1) The City's sewer CCN Application be amended consistent with this pleading; and
- (2) That the City be granted any such further relief as allowed by law.

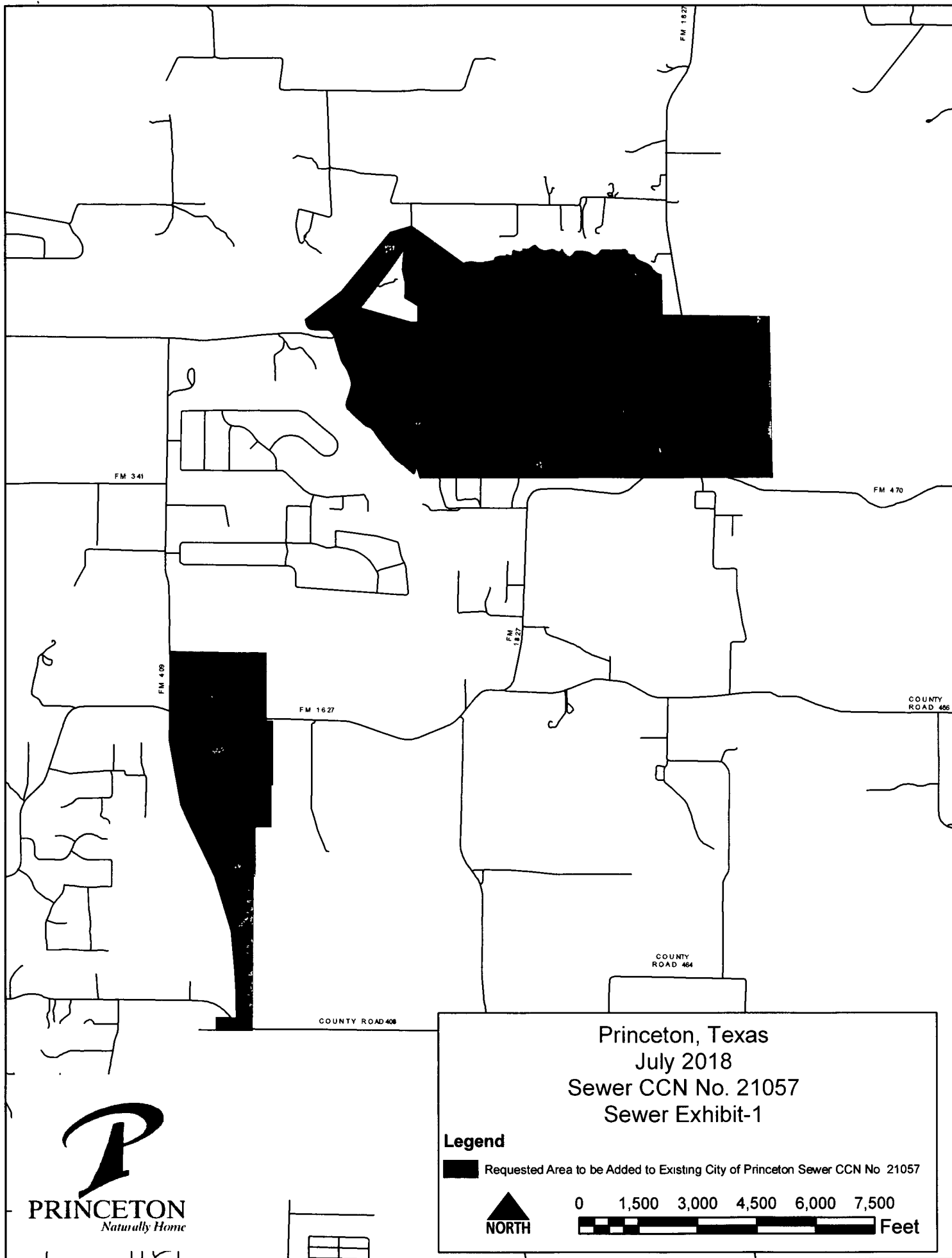

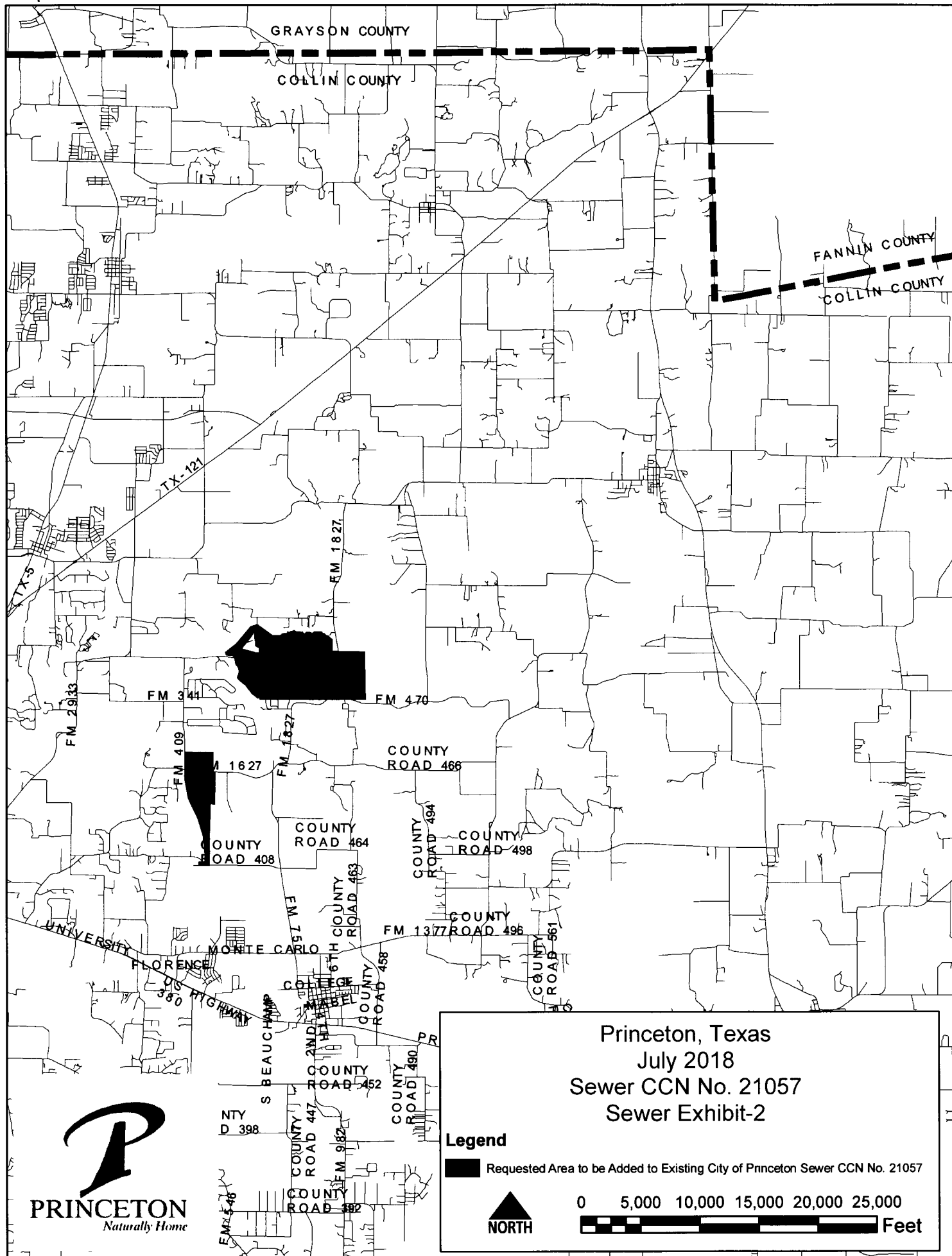
