#### STAFF'S PROPOSED PROCEDURAL SCHEDULE

**COMES NOW** the Staff of the Public Utility Commission of Texas (Staff), representing the public interest and files this request for an extension:

## I. Background

On February 6, 2017, the City of Princeton (Princeton) filed an application to amend water certificate of convenience and necessity No. 13195 and sewer CCN No. 21057 and to decertify a portion of Altoga Water Supply Corporation (Altoga) in Collin County.

On May 2, 2018, the Administrative Law Judge (ALJ) issued Order No. 13, establishing a procedural schedule for processing this docket. On May 23, 2018, North Collin Special Utility District (North Collin SUD) and Altoga Water Supply Corporation (Altoga WSC) filed a request to intervene and demanded a hearing. On May 29, 2018, Princeton filed a joint request to amend the procedural schedule. On June 7, 2018, Princeton filed an additional request to amend the procedural schedule. On July2, the parties filed a joint motion to amend the application and North Collin SUD and Altoga WSC withdrew their intervention request and demand for a hearing. On July 25, 2018, the City of Princeton filed revised CCN mapping information in response to Suzy O. Kemp's July 17, 2018, request to be excluded from the proposed service area.

#### II. Proposed Schedule

Staff proposes the following procedural schedule:

Deadline for the Applicant to file signed consent forms with the Commission	August 28, 2018
If no hearing is requested, deadline for Commission Staff to file a final recommendation on the application	September 4, 2018
If no hearing is requested, deadline for parties to file joint proposed findings of fact and conclusions of law	September 11, 2018
