Re: CCN Clarification

In an effort to correct a mapping error and identify appropriate CCN coverage. NHWSC CCN # 11267 is relinquishing 55.8 acres to Water Necessities CCN # 12243 Dairyland Heights. This is clarified in the attached documents 17-170B revised 6/20/2017 and DairyLand Heights Exhibit c (drawing of Dairyland Heights Subdivision). We have not nor have we ever served these properties for retail public water.

Water Necessities CCN # 12243 is relinquishing to NHWSC CCN # 111267 35.08 acres. Located just north of Mormon Church House Rd. This area is not populated and has not ever been serviced by Water Necessities, but was misplaced in previous web viewer.

Regarding DairyLand Heights there is a difference of 20.72 acres between the old subdivision and new revised CCN area in the interest and benefit of Water Necessities.


Regarding Whispering Pines in CCN # 12243, the NHWSC CCN #11267 and Water Necessities CCN # 12243 are to decertify land in the Whispering Pines subdivision area. The Water Necessities, Inc. will decertify 2.1 acres (1.4, and 0.7) as a revision of their CCN 12243, the two areas as detailed in exhibit d (Docket 46851 Large scale map). NHWSC will decertify 14.2 acres, which will bring the subdivision of Whispering Pines to a total 27.31 acres. See exhibit d (Docket 46851 Large scale map) and exhibit 17-170A Dated 4/3/2017 and Exhibit E (General Location Docket 46851) and Drawing of Whispering Pines subdivision.

In our understanding, no compensation will be sought by NHWSC or Water Necessities for these Changes. These changes in the CCN's are in an effort to define our CCN boundaries and ensure that the residents of these areas are able to continue being supplied with water.






