

LEGACY STABLES, LLC'S MOTION TO WITHDRAW APPLICATION WITHOUT PREJUDICE TO REFILING

COMES NOW, Legacy Stables, LLC. (the "Petitioner") files this Motion to Withdraw Petition Without Prejudice to Refiling pursuant to PUC Proc. R. 22.181(g)(2) and in support thereof would respectfully show as follows:

Petitioner filed its original petition with the Public Utility Commission of Texas ("PUC") seeking expedited release from the Marilee Special Utility District's Certificate of Convenience and Necessity ("CCN") No. 10150 on February 17, 2017, and its Amended Petition on April 4, 2017. PUC Proc. R. 22.181(g)(2) permits a party to withdraw an application after the presentation of its direct case, but prior to the issuance of a proposed order or proposal for decision, upon finding of good cause by the presiding officer. Petitioner has concluded that in consideration of judicial economy and beneficial use of resources of all of the Parties to this Docket, Petitioner prefers to withdraw the petition in light of PUC's determination of deficiencies in a related petition.

WHEREFORE, PREMISES CONSIDERED, Patricia Miller Deason respectfully requests that the PUC allow Petitioner to withdraw its petition without prejudice to refiling the same pursuant to PUC Proc. R. 22.181(g)(2).
