# ORDER NO. 1 REQUIRING COMMENTS ON ADMINISTRATIVE COMPLETENESS OF THE PETITION, NOTICE, OTHER PROCEDURAL MATTERS, AND ESTABLISHING PROCEDURAL SCHEDULE

# I. Application

On February 17, 2017, Legacy Stables, LLC filed an application with the Commission for an expedited release of 71.71 acres from Marilee Special Utility District's water certificate of convenience and necessity number 10150 in Collin County under Texas Water Code § 13.254(a-5) and 16 Texas Administrative Code § 24.113(r) (TAC).

# II. Requiring Comments on Administrative Completeness of Application and Notice

By March 20, 2017, Commission Staff shall file comments on the administrative completeness of the petition and notice.<sup>1</sup> Notice of this petition will appear in the March 3, 2017, issue of the *Texas Register*. A copy of the notice filed with the *Texas Register* is being provided to Marilee SUD at their address of record:

Marilee Special Utility District P.O. Box 1017 Celina, TX 75009-1017

Marilee SUD must file a motion to intervene by March 20, 2017 in order to participate as a party in this proceeding.

Note: 16 TAC § 24.8(a) requires the Commission to review this petition for administrative completeness within 30 days from the date the petition is file stamped by the Commission's Central Records Division. The 30<sup>th</sup> day in this case is Sunday, March 19, 2017, a day the Commission is not open for business. Therefore, under Tex. Gov't Code Ann. § 311.014(b) and in accordance with 16 TAC § 22.4, the period shall conclude on the first day after the deadline that the Commission is open for business.

# III. Establishing Procedural Schedule

The following procedural schedule shall apply to this proceeding:

Publication of Texas Register notice	March 3, 2017
Commission Staff's comments on administrative completeness and notice	March 20, 2017
Deadline for Marilee Special Utility District and other affected persons to file a written protest or motion to intervene and file comments on the petition	March 20, 2017

Additional deadlines will be established after the petition is deemed administratively complete.

# IV. Filing Requirements

Unless otherwise specified, an original and 10 copies of documents relating to this proceeding must be filed with the Commission filing clerk.<sup>2</sup> A copy of each document filed with the Commission must also be served on all parties.<sup>3</sup> All filings can be accessed on the PUC Interchange, <a href="http://interchange.puc.texas.gov">http://interchange.puc.texas.gov</a>.

All parties shall provide their current addresses, telephone, and facsimile numbers if available, to all other parties and the Commission by filing and serving all parties with such information. Each party shall provide the Commission and all parties with updated address, telephone, and facsimile information if such information changes. The telephone and facsimile numbers will be placed on the service list for this proceeding. Parties are responsible for updating their own service lists to reflect changed information and the addition of any other parties.

# V. Ex Parte Communications

Ex parte communications with the administrative law judges and presiding officer are prohibited.<sup>4</sup> Parties shall communicate with the ALJs only through written documents filed with

the Commission's Filing Clerk and served on all parties. Questions concerning this Order or any other order must be submitted in writing, filed with the Commission, and served on all parties of record.
