### AQUA TEXAS' REQUEST FOR EXTENSION OF DEADLINES

TO THE HONORABLE ADMINISTRATIVE LAW JUDGE:

COMES NOW, Aqua Utilities, Inc., Aqua Development, Inc., Kerrville South Water Company, Inc., and Harper Water Company, Inc. d/b/a Aqua Texas ("Aqua" or "Applicants") and files this Request for Extension of Deadlines. In support thereof, Aqua would show the following.


On February 22, 2017, Aqua filed its Southwest Region regional true-up report and requested approval of a decrease in its regional pass-through gallonage charge rate. Aqua filed supplemental information and proof of notice on March 7, 2017. On March 15, 2017, Commission Staff recommended finding that the information and proof of notice provided was sufficient to collect the pass-through rate as noticed, but also recommended ordering Applicants to provide documentation of line loss as described in a Staff memorandum. On March 16, 2017, Aqua was so ordered by the Honorable Administrative Law Judge ("ALJ") to file this information by April 7, 2017.

Aqua conferred with Commission Staff and both agreed that additional time is necessary to address this issue and develop information for filing in the manner intended by Staff's request. Staff agreed to an extension of the deadline for same for an additional two weeks. Therefore, Aqua requests a 14-day extension of current deadlines. This extension would make April 21, 2017 the new deadline for Aqua to file supplemental line loss information and May 1, 2017 the new deadline for Commission Staff to provide a final recommendation on this application.

**PRAYER**

Applicants respectfully request that the Honorable ALJ issue an order approving Aqua's request for a 14-day extension of the existing deadlines and setting out the amended deadlines requested herein.
