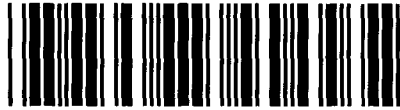

**COMMISSION STAFF'S COMMENTS**

**COMES NOW** the Staff of the Public Utility Commission of Texas (Staff), representing the public interest, and files these comments. In support thereof, Staff shows the following:

**I. BACKGROUND**

On February 22, 2017, Aqua Development, Inc., Kerrville South Water Company, Inc., and Harper Water Company, Inc. dba Aqua Texas (Aqua Southwest) filed its Southwest Region Regional true-up report and requested approval of a decrease in its pass-through gallonage fee. The requested effective date for the pass-through rate change is March 1, 2017. On March 16, 2017, the ALJ ruled that Aqua Southwest could begin collecting the revised pass-through rate as notice, pending final approval. Aqua Southwest was also given the deadline of April 7, 2017 to provide the information requested by Staff. Staff was given the deadline of April 17, 2017 to then file its final recommendation. This pleading is therefore timely filed.

**II. COMMENTS**

Aqua Southwest requested a 14 day extension of their deadline, and Staff is unopposed to this request. This request would extend Staff's deadline for a final recommendation to May 1, 2017. This additional information would assist in forming Staff's final recommendation.




