To whom it may concern,

On April 1, 2016 my office received a recommendation from your staff that our pass through rate increase submitted for Oak Hill Estates Water Company was not sufficient for the following reasons:

- 1) Improperly used the pass-through provision formula from its approved tariff
 Response: I have recalculated the rate using the formula correctly and made this
 correction on a second customer notice that was sent out to all customers receiving
 water service on April 3, 2017(a copy of the notice is attached for your records)
- 2) Included language from a version of 16 TAC §24.21 that was changed after its amendment on December 4, 2016

 Response: I have corrected the wording to match the December 4, 2016 amended wording on the notice sent to customers on April 3, 2017.
- 3) Delinquent in paying its Regulatory Assessment Fees to the Texas Commission on Environmental Quality (TCEQ)

Response: I have contacted the TCEQ regarding the missing payment from 2003. I am waiting on a response from TCEQ on how to correct the records.

PASS THROUGH RATE PROVISION: For utilities subject to changes in cost imposed by any non-affiliated provider of purchased water or sewer or a groundwater conservation district having jurisdiction over the Utility, these increases shall be passed through as an adjustment to the base rate and gallonage charge according to the formulas:

Adjusted Gallonage Rate (AG) = G + [B/(1 - L)], Where:

AG = adjusted gallonage charge, rounded to nearest one cent;

G = approved gallonage charge, per 1,000 gallons;

B = change in fee (per 1,000 gallons);

L = water or sewer line loss for preceding 12 months, not to exceed 0.15 (15%)

Adjusted Gallonage Rate = Approved Gallonage Charge + [change in fee/(1-water loss)] Gallon Rate AG = [2.90/1-0.13] = [2.90/0.87] = \$3.33

To modify the pass through provision, the utility must comply with all notice and other requirements of 30 TAC 291.21(h).

This notice is to make you aware that the North Harris County Regional Water Authority rate charged to you on your monthly water bill is increasing \$ 0.57 from \$2.76 per 1,000 gallons billed to \$3.33 per 1,000 gallons billed effective with bill due 07/16/2017 (water usage from 05/21/2017 to 06/21/2017).
