#### JOINT RESPONSE TO ORDER NO. 5

Commission Staff (Staff) of the Public Utility Commission of Texas (Commission) and Wolfe Air Park Civic Club, Inc. (Applicant) (collectively, Parties) file this in response to the Office of Policy and Docket Management's Order No. 5, which required the Parties to jointly file a responsive pleading by April 11, 2019. Thus, this response is timely filed.

# I. Joint Response

On December 20, 2018, the Commission issued an order (Order) remanding the application to the administrative law judge (ALJ) to enable the Applicant to file a proposed tariff in the form prescribed by the Commission. The Order also states that, if a proposed tariff is filed, then the Commission can again consider the proposal for decision issued by the State Office of Administrative Hearings.

On January 29, 2019, Wolfe Air Park Civic Club, Inc. (Applicant) filed a proposed tariff in response to the Order.

Staff reviewed the Applicant's proposed tariff, and, in lieu of modifying Applicant's proposed tariff, Staff filed its own proposed tariff on April 4, 2019, which corrected errors in Applicant's proposed tariff, including, but not limited to, the insertion of the Applicant's CCN number, updated rule references, and deleting non-applicable fees. The Applicant authorized Staff to report that the Applicant supports Staff's version of the tariff.

Since Staff has provided a proposed tariff, with which the Applicant agrees, Staff recommends that this matter is ready for return to the Commission for its consideration of the



proposal for decision. The Applicant authorized Staff to report that it agrees with this recommendation.

## III. Conclusion

Staff respectfully recommends return of this docket to the Commission for its consideration of the proposal for decision.
