MOTION TO CORRECT ENTITY NAME**

Commission Staff (Staff) of the Public Utility Commission of Texas (Commission) files this response to the Office of Policy and Docket Management’s Order No. 7, which required Staff to file a certificate and map by July 25, 2019. Thus, this response is timely filed.

**I. Response**

Staff files the attached certificate (Attachment A) and map (Attachment B) in compliance with Order No. 7.

**II. Motion to Correct Entity Name**

While finalizing the final map and certificate, it was brought to Staff’s attention that, according to the Texas Secretary of State database, the correct name for the utility in this docket is “Wolfe Airpark Civic Club, Inc.,” not “Wolfe Air Park Civic Club, Inc.” Thus, Staff respectfully requests for the Administrative Law Judge (ALJ) to correct the Final Order issued on June 13, 2019 to reflect the correct entity name.

Staff respectfully recommends the adoption of the recommendations above.





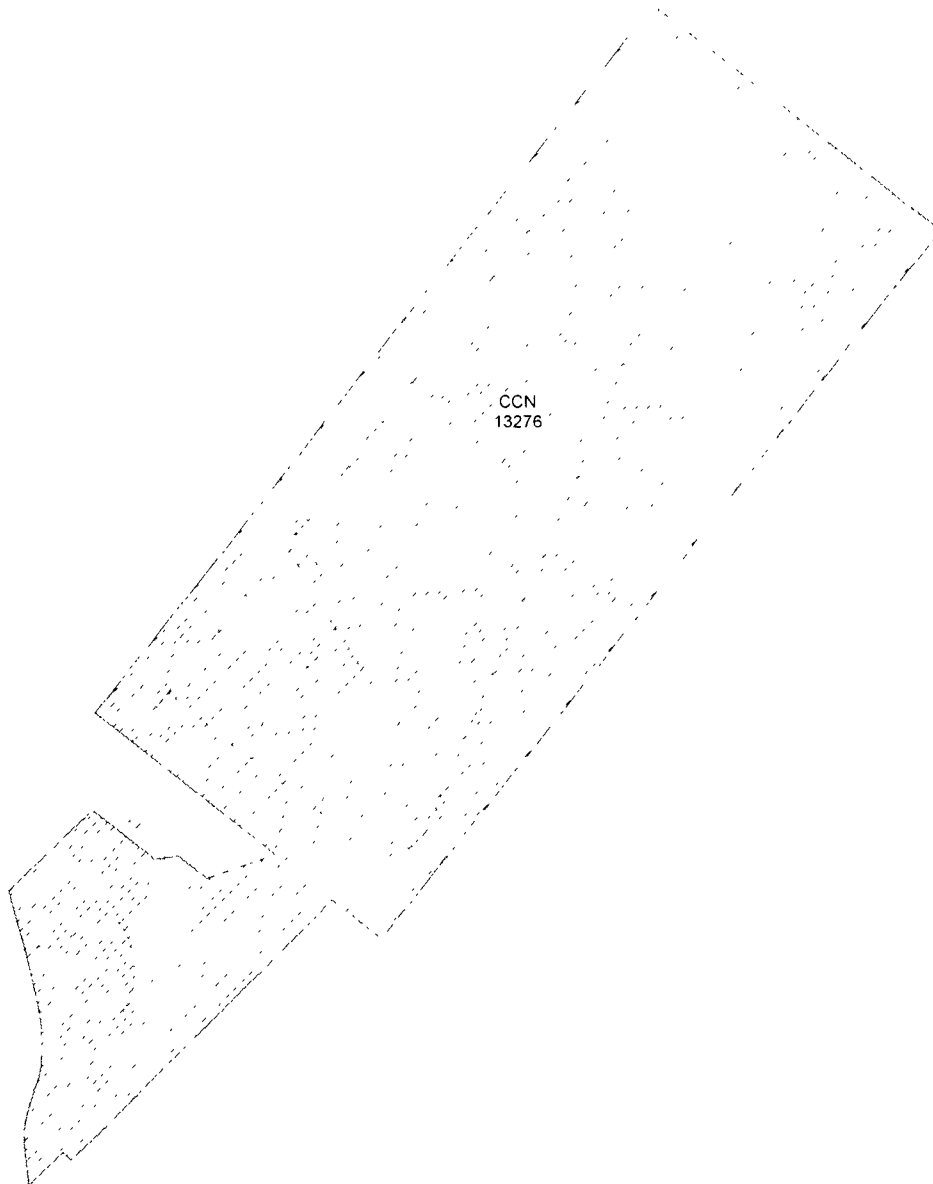
