ORDER NO. 8 APPROVING CERTIFICATE AND MAP AND GRANTING EXTENSION OF TIME

This Order addresses Commission Staff's July 25, 2019, response to Order No. 7, requiring a certificate and map in accordance with the final order entered in this proceeding on June 13, 2019 and Wolfe Airpark Civic Club, Inc.'s July 26, 2019, request for extension of time to comply with the recording requirements of Texas Water Code § 13.257(r) and (s) and file proof of the recording with the Commission.

The attached Certificate of Convenience and Necessity number 13276 is approved and issued to Wolfe Airpark. The Commission's official service area boundary map, attached to this Order, will reflect the changes described in the final order.

Wolfe Airpark's request is granted with the following modification. Wolfe Airpark must, within 31 days of receiving this Order, record a certified copy of the approved certificate and map, along with a boundary description of the service area, in the real property records of each county in which the service area or a portion of the service area is located, and submit to the Commission evidence of the recording.




