**ORDER NO. 6
GRANTING MOTION TO INTERVENE**

This Order addresses John McRae's August 11, 2017 motion to intervene and request for a public hearing in this proceeding. Mr. McRae owns land within one mile of the proposed CCN area, on which he has three groundwater wells. Mr. McRae is concerned that Vineyard Ridge, LLC's groundwater pumping to serve its service area will adversely affect his groundwater wells located nearby. Pump testing has not yet been completed on Vineyard Ridge's test wells, however in an abundance of caution, Mr. McRae filed a request to intervene within the deadline established in this proceeding. Mr. McRae appears to have a justiciable interest in this proceeding. No objections to the motion to intervene were filed.

The motion to intervene of John McRae is granted. The request for a public hearing will be addressed in a subsequent order.
