There were some additional date changes in finding of fact 84 that I did not change in the previous memorandum that also need to be modified. The July 5, 2017 and March 23, 2017 dates were incorrect. Therefore, the following finding of fact 84 should be used instead of the earlier provided language.

84. In SOAH Order No. 6 issued on April 5, 2018, the SOAH ALJ ~~admitted evidence~~, remanded the proceeding to the Commission, ~~and~~ dismissed the SOAH docket, and admitted the following into evidence: (a) Vineyard Ridge's application, filed on March 15, 2017; (b) Vineyard Ridge's supplemental information, filed on April 17, 2017, May 3, 2017, and February 13, 2018; (c) an affidavit of notice to neighboring systems and landowners, filed on July 17, 2017; (d) Vineyard Ridge's consent forms, filed March 23, 2018; and (e) Commission Staff's final recommendation, including attachments, filed on April 2, 2018.
