**RE: PETITION TO OPPOSE WATER RATE INCREASE BY RATEPAYERS OF THE
BEAR CREEK SPECIAL UTILITY DISTRICT (fka LAVON SPECIAL UTILITY DISTRICT)**

Dear TCEQ Water Supply Division Representative,

Come now DEBORAH FATO and CHARLES TESKE, Jr. (as "Co-Representatives"), together with over 300 Ratepayers ("Petitioners"), which comprise more than ten percent (10%) of the 2118 account holders of the BEAR CREEK SPECIAL UTILITY DISTRICT, formerly known as the LAVON SPECIAL UTILITY DISTRICT [per name change 2015] ("SUD"), to file this Petition opposing the two (2) recent water rate increases imposed in 2016 by the SUD's board of directors, the last rate increase having an 'Effective Date' of January 1, 2017. We respectfully submit the attached original Petition, with over 300 Ratepayers' signatures on 52 Petition sheet pages, and four (4) copies of this Petition letter for your consideration.

The Petitioners request that the Texas Commission on Environmental Quality ("TCEQ") review the decision of the individuals serving on the SUD's Board of Directors and General Manager, and determine if the rates imposed by the two 2016 increases are just and reasonable. The old rates charged by the SUD are:

And the new rates listed in the December 16, 2016 Notice are:

\$5.50/1,000 Gals for 0 to 5,000 Gals	A 38% increase in one year
\$6.10/1,000 Gals for 5,0001 to 10,000 Gals	A 44% increase in one year
\$7.00/1,000 Gals for 10,001 to 15,000 Gals	A 40% increase in one year
\$8.65/1,000 Gals for 15,001 to 25,000 Gals	A 38% increase in one year
\$9.75/1,000 Gals for over 25,001 Gals	A 39% increase in one year
\$9.75/1,000 Gals for Construction/Meter	A 95% increase in one year

By comparison, the North Texas Municipal Water District ("NTMWD") Rate increase per 1000 Gallons during this same time period was raised 22%. The NTMWD Rate for Member Cities during this same time period was 23%. **The SUD's rate increase does not represent a reasonable increase to pass on to its Ratepayers. The increase is excessive. The increased rates are in addition to a monthly \$25.00 'service fee' charged each Ratepayer, which is over and above usage and pays for 0 gallons of water.**

Although the SUD's notice letter stated that the Effective Date of the rate increase was January 1, 2017, the Notice of Rate Increase announced that the new rates would be ascribed to the water bills reporting period of December 19, 2016, and the postmark on the notification was also December 19, 2016. This was not in adherence with the required 30 day notification period of the rate increase. The rate increase was imposed and our water meters were read the same day the Notice letter was mailed to the Ratepayers. We object to this improper method of providing notice by the SUD. [See **Exhibit 1**].

The December 19, 2016 rate increase was the second increase made by the SUD in the year 2016 – the first rate increase had an Effective Date of May 19, 2016. [See **Exhibit 2**]

It was learned by Co-Representatives last December 2016 that the SUD had also filed its *Application to Obtain or Amend a Water or Sewer Certificate of Convenience and Necessity* ("CCN") with the Public Utilities Commission ("PUC") on or about May 10, 2016, without providing notice or open discussion to its Ratepayers/Members. Ratepayers contend the proposed engagement of a new business venture by the SUD could have created a need for more revenue, which allegedly triggered the May 2016 water rate increase.

The Ratepayers took issue with the SUD using profits from its water customers to build a new sewer system. A great many customers are already on a septic system, or an existing city sewer system, and would not benefit from this service but as a Ratepayer would still bear the burden of paying for it. (It was stated at the March 14, 2017 SUD Board of Directors meeting that the CCN Application was withdrawn in response to numerous concerns expressed by Ratepayers.)

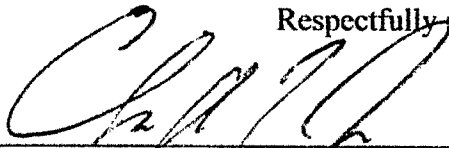

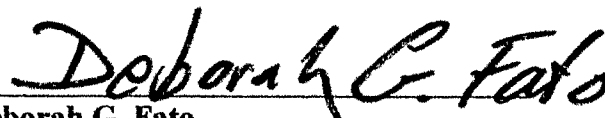

RATE INCREASE NOTIFICATION

Bear Creek Special Utility District (SUD) purchases all treated water from North Texas Municipal Water District. North Texas Municipal Water District notified the SUD in September 2016 that the cost of treated water would increase by 10.1% beginning October 1, 2016.

The rising costs of rates are due to three primary issues according to NTMWD:

- Maintaining aging infrastructure
- Complying with increasing regulatory requirements
- Constructing projects/infrastructure to keep up with growing needs

When presented with such increases, the Board of Directors are still determined to meet the growing needs of the customers, continue to improve services, and maintain the existing investment of the infrastructure. As the SUD plans for future needs, the existing systems and infrastructure, some constructed 50 years ago, require maintenance and improvements to sustain reliability, comply with regulations, and ensure public health and safety. In order to meet these goals, the Board of Directors passed a budget that will meet all the above obligations, fund improvement projects, as well as keep the District financially stable. Therefore, the Board has approved an increase in the water rates as follows:

RATE INCREASE NOTIFICATION

Due to the increasing costs of purchasing treated water from the North Texas Municipal Water District, the Board of Directors has approved an increase in Bear Creek SUD water rates. North Texas Municipal Water District has passed on increases totaling 40% since 2013. Bear Creek SUD has not passed along any increase during the past three years to its customers.

When presented with such increases, the Board of Directors is still determined to meet the growing needs of its customers, continue to improve services, and maintain the existing investment of the District's infrastructure. In order to meet these goals, the Board of Directors approved a budget that will meet all the above obligations, fund improvement projects, as well as keep the District financially stable. Therefore, the Board has approved an increase in the water rates as follows:
