#### **DEFINITIONS**

- A. "Malakoff," "the Company" or "you" refers to the City of Malakoff and any person acting or purporting to act on their behalf, including without limitation, attorneys, agents, advisors, investigators, representatives, employees or other persons.
- B. "Document" includes any written, recorded, or graphic matter, however produced or reproduced, including but not limited to correspondence, telegrams, contracts, agreements, notes in any form, memoranda, diaries, voice recording tapes, microfilms, pictures, computer media, work papers, calendars, minutes of meetings or other writings or graphic matter, including copies containing marginal notes or variations of any of the foregoing, now or previously in your possession. - STAFF 1-3 Please provide copies of sample wholesale invoices for sewer utility service from the City of Malakoff for the period beginning December 2016 and ending March 2017.
- STAFF 1-4 Please provide copies of sample invoices for sewer utility service from the City of Star Harbor to two separate residential ratepayers for the period beginning December 2016 and ending March 2017.
- STAFF 1-5 Please provide copies of sample invoices for sewer utility service from the City of Malakoff to two separate residential ratepayers for the period beginning December 2016 and ending March 2017.
- STAFF 1-6 Please provide information as to whether the City of Star Harbor, the City of Malakoff, or a third entity or entities maintains the distribution lines and meters connected to the residential ratepayers outside the city limits of the City of Malakoff.
