COMMISSION STAFF'S FINAL RECOMMENDATION

COMES NOW the Staff of the Public Utility Commission of Texas (Staff), representing the public interest and files this Final Recommendation. In support thereof, Staff shows the following:

I. BACKGROUND

On March 30, 2017, Aqua Utilities, Inc. d/b/a Aqua Texas (Aqua) and the City of Georgetown (Georgetown) (collectively, Applicants) filed an application, pursuant to Texas Water Code § 13.248, for approval of an agreement that would amend their water certificates of convenience and necessity (CCN) in Williamson County. Aqua holds water CCN No. 11157 and Georgetown holds water CCN No. 12369. Aqua, Georgetown, and Hidden Creek Estates, LLC (Hidden Creek), the area to be transferred, agree that Aqua will provide retail water service to the proposed transfer area (Hidden Creek) and Georgetown agrees to transfer the proposed transfer area within Georgetown's CCN to Aqua within the terms of the contract. No city facilities or customers are currently located in the area proposed for transfer. Aqua and Georgetown request that the Commission approve the contract without requiring public notice. The Commission published notice of the application in the *Texas Register* on April 3, 2017.

On April 20, 2017, the Administrative Law Judge (ALJ) issued Order No. 2, instructing Staff to file a final recommendation regarding this application by July 10, 2017. Therefore, this pleading is timely filed.

II. FINAL RECOMMENDATION

Staff has reviewed the application, and as detailed in the attached memo from Jonathan Ramirez of the Commission's Water Utility Regulation Division, Staff recommends that the application be approved. Staff further recommends that the Applicants file a certified copy of the CCN maps, along with a written description of the CCN service areas, in the county clerk's office as required by Tex. Water Code § 13.257(r) and (s) (West 2016).

III. CONCLUSION

Staff respectfully requests that the ALJ issue an order consistent with Staff's recommendations.

On March 30, 2017, Aqua Utilities, Inc. dba Aqua Texas (Aqua) and the City of Georgetown (Georgetown) (collectively, Applicants) filed an application for approval of a service agreement pursuant to Texas Water Code (TWC) §13.248, that would amend their water Certificates of Convenience and Necessity (CCN) in Williamson County.

The Applicants have agreed to transfer a portion of the City of Georgetown's CCN No. 12369 to Aqua, CCN No. 1157.

The application meets all of the statutory requirements of TWC Chapter 13 and 16 TAC Chapter 24 rules and regulations. Staff recommends approval of the application.

The Applicants consented to the attached maps and certificates, on July 3rd and 5th, 2017.

Based on the above information, Staff recommends that:

- Application be approved;
- The attached tariff pages with the subdivisions, maps and certificates be provided to the Applicant.

Staff further recommends that the Applicant file certified copies of the CCN maps along with a written description of the CCN service area in the county clerk's office pursuant to TWC §§ 13.257 (r)-(s).


