Dear Filing Clerk:

Per PUC Staff's Recommendation on Closing Documents dated November 28, 2017, PUC staff indicated that the appropriate information regarding the transfer of deposits was not provided. This letter is to formally provide the additional information for the verification of the transfer of deposits as requested in Order No. 6 for the above stated application and docket.

Per 16 TAC § 24.109, if there are outstanding customer deposits, within 30 days of the actual effective date of the transaction, the transferor and the transferee shall file with the commission, under oath, in addition to other information, a list showing the following:

- (1) the names and addresses of all customers who have a deposit on record with the transferor;
- (2) the date such deposit was made;
- (3) the amount of the deposit; and
- (4) the unpaid interest on the deposit.

All such deposits shall be refunded to the customer or transferred to the transferee, along with all accrued interest.
