

The sale is scheduled to take place as approved by the Commission (V.T.C.A., Water Code § 13.301). The transaction and the transfer of the CCN includes the following subdivision: Dolly Hellinger Subdivision

The requested area subject to this transaction is located approximately 3.5 miles northwest of downtown <u>Cistern</u>, Texas, and is generally bounded on the north by <u>County Road 310</u>; on the east by <u>Bastrop/ Fayette County Line</u>; on the south by <u>Janca Shade Road</u>; and on the west by <u>County Road 297</u>.

The total requested area for the water CCN being transferred includes approximately $\underline{2035}$ acres and $\underline{0}$ current customers.

This transaction will have the following effect on the current customers' rates and services: There are no current Aqua WSC customers in this area or effects on rates and services to these residents.

You may request a public hearing. A request for a public hearing must be in writing and include: (1) your name, mailing address, and daytime telephone number; (2) the applicant's name, docket number or another recognizable reference to this application; (3) the statement, "I/we request a public hearing"; (4) a brief description of how you or the persons you represent would be adversely affected by the granting of the application for a CCN; and (5) your proposed adjustment to the

application which would satisfy your concerns and cause you to withdraw your request for a hearing.

Hearing requests, comments or requests to intervene should be filed with the:

within thirty (30) days from the date of this publication or notice. A public hearing will be held only if a legally sufficient hearing request is received or if the Commission on its own motion requests a hearing. Only those individuals who submit a written hearing request will receive notice if a hearing is scheduled.

Persons who wish to intervene in the proceeding or comment upon action sought should contact the Public Utility Commission, P.O. Box 13326, Austin, Texas 78711-332, or call the Public Utility Commission at (512) 936-7136. The deadline for intervention in the proceeding is (30 days from the mailing or publication of notice, whichever occurs later, unless otherwise provided by the presiding officer). You must send a letter requesting intervention to the commission which is received by that date.

If a valid public hearing is requested, the Commission will forward the application to the State Office of Administrative Hearings (SOAH) for a hearing. If no settlement is reached and an evidentiary hearing is held, SOAH will submit a recommendation to the Commission for final decision. An evidentiary hearing is a legal proceeding similar to a civil trial in state district court.

Portion of Aqua WSC Water CCN No. 10294 to be Transfered to Fayette WSC CCN No. 10726






Map Legend
