

RE: Tariff Control No. 47051 – Application of Community Utility Company to Implement a Pass-Through Rate Change

## NOTICE OF APPROVAL

This Notice addresses Community Utility Company's application for a pass-through rate change due to an increase in water use fees imposed on the utility by the City of Houston for the utility's mandatory participation in Houston's ground water reduction program. The rate change affects customers in the Forest Manor (public water supply (PWS) #1010264) and Heathergate (PWS #1011302) subdivisions. The requested effective date for the pass-through rate change was April 1, 2017.

On May 1, 2017, Commission Staff recommended that the application be deemed sufficient and approved, as specified in the pleading and attached memorandum of Jonathan Ramirez of the Commission's Water Utility Regulation Division. Commission Staff recommended approval of an increase in Community's pass-through fee from \$.99 to \$1.05 per 1, 000 gallons and provided revised tariff pages for Community. However, Commission Staff stated that because notice of the requested rate change was sent to customers on April 14, 2017, the effective date should be May 1, 2017, not April 1, 2017.

Consistent with Commission Staff's recommendation, Community's application is sufficient and it is approved. A new pass through rate of \$1.05 per 1,000 gallons for Community's customers in the Forest Manor and Heathergate subdivisions is approved

# Pass Through Fees:

In addition to the gallonage charge, the City of Houston Groundwater Reduction Plan (GRP) Fee of <u>\$1.05 per 1,000 gallons</u> used will be charged to the customers of <u>Forest Manor and</u> <u>Heathergate Subdivisions only</u>. The pass through fees are adjusted for line loss. (Tariff Control No. 47051)

Capital Improvement Surcharge:

<u>\$40.00</u> per month per connection for 180 months or project completion, whichever comes first. This fee is requested to collect sufficient revenues to pay for capital improvements mandated by the Texas Commission on Environmental Quality (TCEQ) and to bring the utility's facilities into compliance with TCEQ minimum standards. This surcharge can be increased or decreased based on the amount necessary to make required PUC approved capital improvements, thirty days after notice of any change in the surcharge is sent to all affected customers and the filing of notice with the PUC as required by 30 TAC 24.21(h).

FORM OF PAYMENT: The utility will accept the following forms of payment:

Cash X, Check X, Money Order X THE UTILITY MAY REQUIRE EXACT CHANGE FOR PAYMENTS AND MAY REFUSE TO ACCEPT PAYMENTS MADE USING MORE THAN \$1.00 IN SMALL COINS. A WRITTEN RECEIPT WILL BE GIVEN FOR CASH PAYMENTS.

REGULATORY ASSESSMENT.....<u>1.0%</u> PUC RULES REQUIRE THE UTILITY TO COLLECT A FEE OF ONE PERCENT OF THE RETAIL MONTHLY BILL AND TO REMIT FEE TO THE TCEQ.

# PASS-THROUGH ADJUSTMENT CLAUSE:

The utility may pass on only to those customers served by a system subject to the jurisdiction of any Regional Water Authority and/or any Groundwater Reduction Plan, any increase or decrease in its Underground Water District Pumpage Fee or Purchased Water Fee, thirty days after noticing of any change to all affected customers and filing notice with the PUC as required by 30 TAC 24.21(L). The charge per customer shall be calculated as follows:

- A = UTILITY'S ANNUALIZED CHANGE IN COST OF WATER SUBJECTED TO DISTRICT'S FEE

  - L = PERCENTAGE SYSTEM WIDE LINE LOSS FOR THE PROCEEDING 12 MONTHS, NOT TO EXCEED 15%

# PURCHASED WATER AND/OR DISTRICT FEE PASS THROUGH CLAUSE:

Changes in fees imposed by any non-affiliated third party water supplier or underground water district having jurisdiction over the Utility shall be passed through to only the water system(s) affected by the increase or fee as an adjustment to the water gallonage charge according to the following formula:

AG = G + B/(1-L), where:

- AG = adjusted gallonage charge, rounded to the nearest one cent:
- G = approved gallonage charge (per 1,000 gallons);
- B = change in purchased water/district gallonage charge (per 1,000 gallons);
- L = system average line loss for preceding 12 months not to exceed 0.15
