How many total active meters (Commercial/Residential) did the MUD service in January, 2012? **QUESTION NUMBER 3.** 

How many total active meters (Commercial/Residential) did the MUD service in June 2017? QUESTION NUMBER 4.

Describe what additional burden in water usage, materials or labor the MUD has undertaken as a direct result of construction and operation of Camp Stryker RV park.

QUESTION NUMBER 5.

Has the MUD engaged any engineer or expert to analyze the MUD's capacity to deliver water to it's customers? If so, provide the contact information for said expert. Provide any written report that exists.

How many meters are utilized by the MUD to service Camp Stryker RV park?

**QUESTION NUMBER 7.** 

Who paid for the installation of the water meter/s referred to in question 6?

**QUESTION NUMBER 8.** 

Has the total amount of water supplied to all customers by the MUD increased or decreased between January 1, 2012 and June 1, 2017? Provide gallonage numbers for the two dates.

**QUESTION NUMBER 9.** 

How much total water in gallonage is utilized by the average house within the MUD district? Give approximate range based on bills.

QUESTION NUMBER 10. \*

How much water has been used to date by the Camp Stryker RV Park in 2017?

QUESTION NUMBER 11

What is the capacity of the MUD'S wells? Please answer in Gallons/minute.

QUESTION NUMBER 12 👍

What additional burden to the MUD caused by the water usage of Camp Stryker RV Park required the MUD to increase its charge for water to the Park in March, 2017 to more than ten times what it charged one month earlier (February, 2017), based on gallonage used.

**QUESTION NUMBER 13** 

What is the capacity of the MUD water and sewer delivery apparatus and what is the current per cent of capacity being utilized? Give water and sewer numbers separately.
