JOINT MOTION TO ABATE

TO THE HONORABLE ADMINISTRATIVE LAW JUDGE:

COME NOW, Quadvest, L.P. ("Quadvest") and the Public Utility Commission Staff ("Commission Staff") and file this Joint Motion to Abate and would respectfully show the following:

I. BACKGROUND

On May 9, 2018, Quadvest filed its First Amended Joint Motion for Admission of Evidence and Adoption of Proposed Notice of Approval in the subject docket (the "Joint Motion"). Subsequent to filing that Joint Motion, on May 17, 2018, Office of Policy and Docket Management ("OPD") approved a pass-thru rate change filed by Quadvest in Docket No. 48041 relating to the same tariff at issue in the subject docket. And, on May 25, 2018, Commission Staff recommended approval of pass-thru rate changes filed by Quadvest in Docket No. 48051 and Docket No. 48052, both of which also relate to the tariff at issue in this docket. The Parties anticipate that OPD will make a final decision on those two dockets within the next ten to fourteen days.

II. MOTION TO ABATE

Based on the goal of having the tariff as finally approved in Docket No. 47072 reflect all PUC approvals, the Parties recommend that Docket No. 47072 be abated pending a final decision in Docket No. 48051 and Docket No. 48052, so that the Parties can revise the tariff being

considered in this docket to incorporate the information from Docket No.'s 48041, 48051 and 48052. The Parties will submit a second amended joint motion reflecting that revised tariff as expeditiously as possible following the final decision in Docket No. 48051 and Docket No. 48052.

III. CONCLUSION

WHEREFORE, PREMISES CONSIDERED, the Parties respectfully request that Docket No. 47072 be abated pending a final decision on the pass-thru rate change requests in Docket No. 48051 and Docket No. 48052 and submittal of a Second Amended Joint Motion for Admission of Evidence and Adoption of Proposed Notice of Approval. The undersigned represents that this motion is submitted with permission of Commission Staff.
