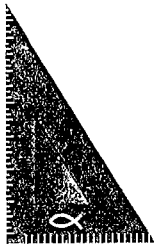

To whom it may concern:

On behalf of our client, Petra Firma Development Group, Inc. ("Petra Firma"), we request an extension to the "Deadline for Applicants to file proof of notice with the Commission" on our Certificate of Convenience and Necessity ("CCN") application (Docket No. 47093). The deadline was given as September 28, 2017. At this time, the notices to landowners, districts, and interested parties have been given. However, we have not received the publisher's affidavit from the local newspaper. We respectfully request that the deadline be extended until October 16. We expect to get the affidavit back by October 8.

In addition to the request for a deadline extension, we are currently submitting the affidavit from the Applicant that notices and maps were sent to the following:

- Tom Green County Judge;
- Lipan-Kickapoo Water Conservation District; and
- Concho Rural Water Corporation (CCN No. 11361).

The CCN area is not within any city's ETJ, and the only landowner within the service area is the president of the Applicant. Therefore, it was not necessary to notify any city or landowner.
