The undersigned ratepayers located outside The City of Canadian hereby appeal the decision of The Canadian City Council affecting the rates charged to them by The City of Canadian Water and Sewer System. The rate change will go into effect on April 18, 2017 being reflected on the bill Mailed May 26, 2017. This rate change affects all current customers using city water or sewer service or both who live outside the current boundaries of The City of Canadian. On January 18, 2017 the ratepayers were notified by the service provider of this rate increase. The undersigned request that the Public Utility Commission of Texas review the decision to determine if the rates established are just and reasonable. The old rates charged by the service provider are the same rate as provided to ratepayers inside the city limits. The new rate is an increase of 50% more to outside city limit customers. An example is 10,000 gallons of water is now \$31.90 and the new rate would be \$47.90. Sewer rate now for 10,000 gallons is \$45.00 and the new rate would be \$67.50. We the undersigned do not believe the city can justify this increase as a reasonable return for services. The undersigned designate Ed Hedgecoke as their representative on this matter.
