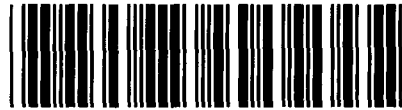

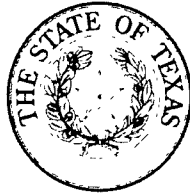

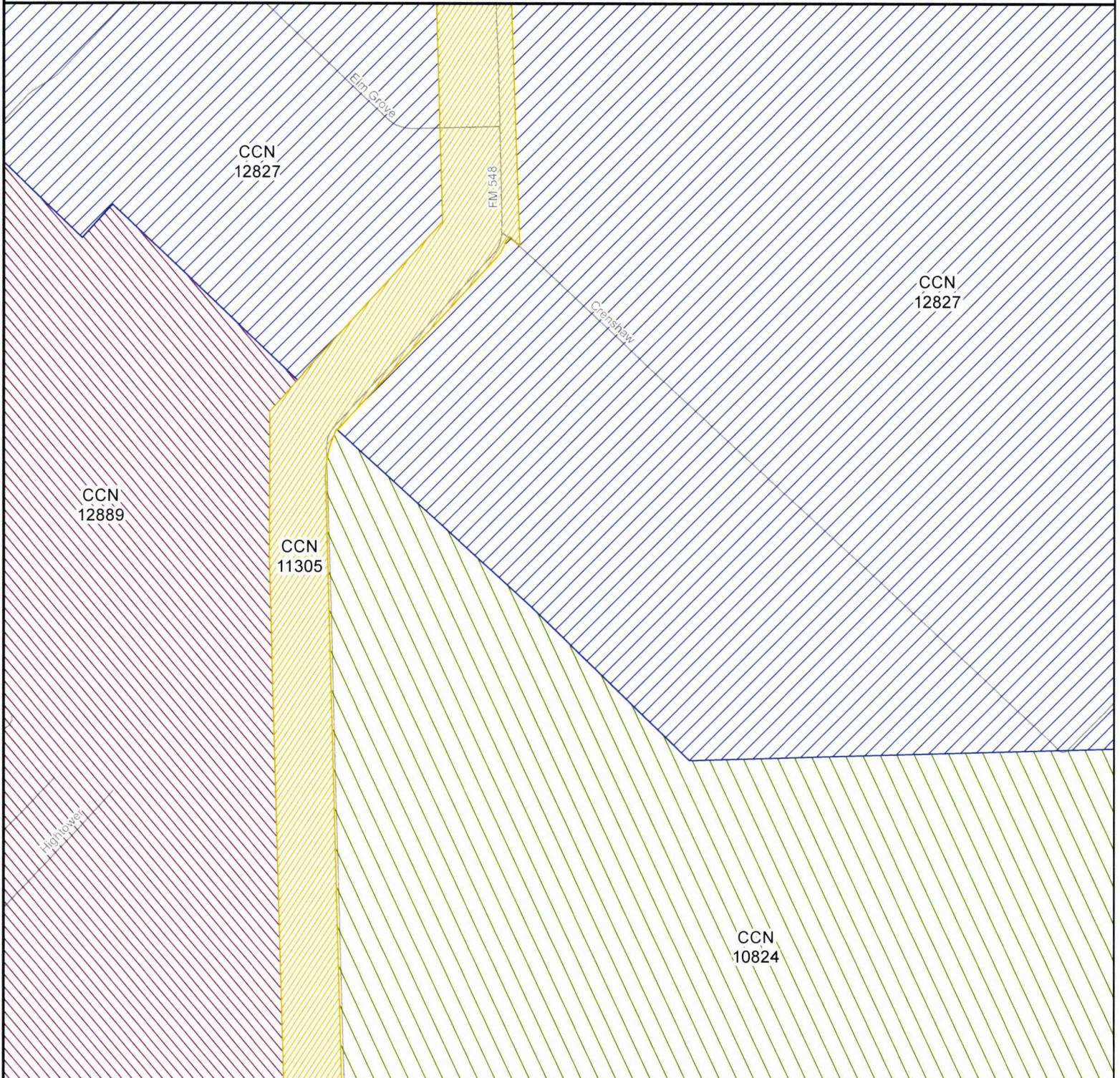
### **Certificate of Convenience and Necessity No. 12827**
