Déar Mr. Day:

As you requested, we have reviewed the Public Utility Commission Interoffice Memorandums dated June 1. 2017 for the sale and transfer of facilities and Certificate Rights from both Parker Creek Estates, LP (PUC Dockett 47112) and Blackland Water Supply Corporation (PUC Dockett 47113).

In both memorandums, the PUC has requested the Applicants provide addition information in the form of proof of submission of plans and specifications and development plans to the TCEQ for the provision of water and sewer service in the areas requested (Comment No. 2).

The City of Royse City water system that will serve the transferred service areas currently has 4,389 internal water system connections and serves another 1,548 system connections through its wholesale water contract with BHP Water Supply Corporation. The City reports the new development to be served by the transferred areas will be developed on a phased basis, with Phase IA and Phase IB having 268 connections. Because the number of proposed connections will not exceed 10% of the total number of existing connections, the proposed improvements for these phases do not qualify as a significant change under 30 TAC 290.39(j)(1)(D) and therefore does not require plans and specifications for the utility improvements to be submitted to the TCEO.

We trust this response satisfies the PUC Interoffice Memorandum regarding additional applicant information and are available to discuss this matter further at your convenience.
