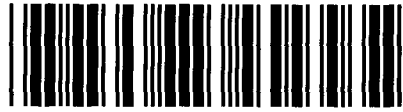

**ORDER NO. 3  
FINDING THE PETITION ADMINISTRATIVELY COMPLETE AND SUFFICIENT,  
ESTABLISHING PROCEDURAL SCHEDULE**

This Order addresses Commission Staff's June 19, 2017 supplemental recommendation that the petition be found administratively complete and deemed sufficient for filing. Commission Staff suggested that this petition filed on May 1, 2017, should not be processed under the new rules for streamlined expedited releases, which became effective May 28, 2017.<sup>1</sup>

Applications are not considered filed with the Commission until a determination of administrative completeness is made.<sup>2</sup> This petition is considered filed the date this order is signed, therefore, the new rules for streamlined expedited releases shall apply. Under the new rules, a final order in this docket must identify what property, if any, is useless or valueless property.<sup>3</sup>

Consistent with Commission Staff's recommendation, the petition is deemed administratively complete. The following procedural schedule shall apply:


