- Staff 1-3 Please explain if there was any transportation expenses for the test year. Please provide the amount and indicate where it is included in the application.
- Staff 1-4 Please explain if the utility has any bad debt. Please provide the amount and indicate where it is included in the application.
- Staff 1-5 Please explain if the utility has any office service and rentals. Please provide the amount and indicate where it is included in the application.
- Staff 1-6 Please explain if the utility incurred any professional services for the year. If so, please provide invoices.
- Please explain the increase in insurance from \$3,855 in 2015 to \$8,990 in 2016 as reflected on page 25 of the application. Please provide invoices and policy documents from Garret Insurance Company which include explanations of what type of insurance is paid for and the amount of coverage.
