COMMISSION STAFF'S SECOND REQUEST FOR EXTENSION OF TIME

COMES NOW the Staff (Staff) of the Public Utility Commission of Texas (Commission), representing the public interest, and files this Request for Extension of Time to file clarifying information in response to the Order Requesting Information. In support thereof, Staff shows the following:

I. BACKGROUND

On July 3, 2016, Kerr County Water Systems, LLC (KCWS) filed an application for a water rate/tariff change with an effective date of August 1, 2017. KCWS currently has approximately 88 connections. At the July 18, 2019 Open Meeting, the Commissioners requested clarifying information regarding the settlement. An Order Requesting Information was filed July 19, 2019, requesting additional information to be filed that can readily be admitted into evidence.

On August 8, 2019, Staff filed its Request for Extension of Time. That pleading states that Staff requires additional time to coordinate with KCWS to obtain and provide the requested information, and requests an extension of the deadline for Staff to provide that information to August 30, 2019. To date, an order addressing that motion has not been issued.

II. REQUEST FOR EXTENSION

Staff files this second motion for extension of time because it requires additional time to provide responses to the information requested in the Order Requesting Information and to obtain agreement from KCWS. Pursuant to 16 Texas Administrative Code § 22.4(b), parties may request that the time allowed for filing any documents be extended for good cause. Staff is working diligently in order to produce this information and requests an extension of the parties' deadline to September 27, 2019.

III. CONCLUSION

Staff respectfully requests the entry of an order granting to above request.
