Pursuant to Texas Water Code § 13.257, Liberty Utilities (Woodmark Sewer) Corp. holder of Certificate of Convenience and Necessity No. 20679, hereby files this Boundary Description for the portion of Liberty Utilities (Woodmark Sewer) Corp.'s CCN No. 20679 which was amended in PUC Docket No. 47175. The area is located in Smith County, Texas.

In accordance with the aforementioned statute, Liberty Utilities (Woodmark Sewer) Corp. affirmatively states that the amended portion of its service area in its aforementioned CCNs is as follows:

The requested utility service area is located approximately 9 miles south of downtown Tyler, Texas, and is generally bounded on the north by Chaparral Run; on the east by Chaparral Run; on the south by Cooks Crossing; and on the west by CR 122.

Liberty Utilities (Woodmark Sewer) Corp.'s additional service area is depicted in the attached PUC map.

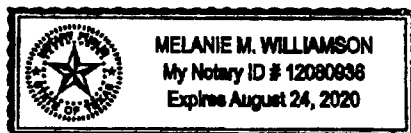

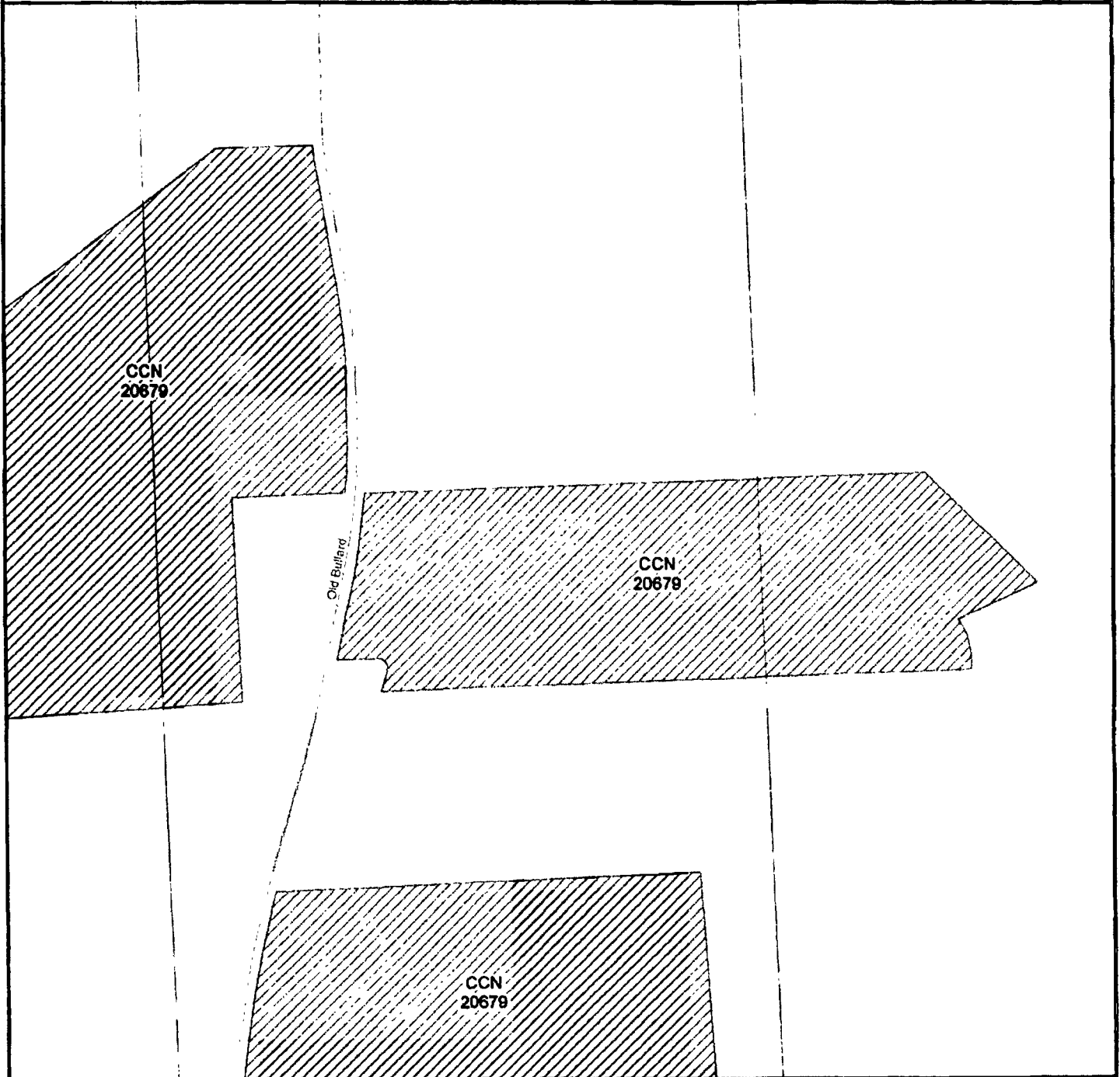
