



DEFINITIONS

- A. "Woodmark," "the Company" or "you" refers to the Liberty Utilities (Woodmark) Corp. and any person acting or purporting to act on their behalf, including without limitation, attorneys, agents, advisors, investigators, representatives, employees or other persons.
- B.
