DEFINITIONS

- A. "Purchasers," "Valley Estates Water Service" or "you" refers to Michael and Heidi Fensterbush and any person acting or purporting to act on their behalf, including without limitation, attorneys, agents, advisors, investigators, representatives, employees or other persons.
- B. - 5) The present tense shall be construed to include the past tense, and the past tense shall be construed to include the present tense.
- 6) If any document is withheld under any claim of privilege, please furnish a list identifying each document for which a privilege is claimed, together with the following information: date, sender, recipients or copies, subject matter of the document, and the basis upon which such privilege is claimed.

- Please provide documentation such as personal financial statements to support the position that Heidi Fensterbush and Michael Fensterbush (Purchasers) can meet one of the leverage tests pursuant to 16 Tex. Admin. Code § 24.11(e)(2). The financial information provided should demonstrate that the Purchasers generate sufficient income and/or cash flow to meet the contract agreement payment terms of \$5,000 per month provided in the supplemental information filed in this docket by the Purchasers on July 19, 2017. This financial information should also show that the Purchasers have the ability to maintain a debt coverage ratio greater than 1.25, or the ability to maintain a debt-to-equity ratio of less than one (1).
- Staff 1-2 Please indicate if the financial statements filed on July 19, 2017 in this docket, pages 9 through 15, are for the operation of the Valley Estates Water Service system only. If not, please indicate the entity or entities represented by the financial statements.
- Staff 1-3 For the financial statements referenced in Staff RFI 1-2:
 - a. Please amend the statements so that the accounting is correct; specifically that assets = liabilities + owner's equity;
 - b. Reconcile the detailed expense amounts to the expenses claimed on pages 10 and 13 of that same filing; and
 - c. Amend the financial statements to include net income effects on the balance sheets as appropriate.
- Staff 1-4 Please provide any voluminous data electronically in Microsoft Excel format, especially the general ledgers and financial statements. Staff notes that confidential information may be filed using the Commission's confidential filing instructions located on the Commission's website.
