To Whom It May Concern:

Kempner Water Supply located at 11986 Highway 190 in Kempner, TX, 76539 has caused the following grievances:

Due to a contract signed in 2006 we, the members of KWSC, subsidize Lampasas' water usage. When Central Texas Water Supply sends out a bill for Lampasas, KWSC pays 63% of that bill while Lampasas pays only the remaining 37%. In the last fiscal year Kempner Water Supply members paid \$633,912.00 while Lampasas only paid \$383,160.00 for THEIR purchase of wholesale water! Attached to this letter you will find a copy of one of the pages from the newsletter that was sent out to KWSC members by KWSC attempting to explain the lawsuit. This "deal" serves as no benefit whatsoever to Kempner Water Supply members and needs to be reviewed.

As a direct result of this contract and the costs associated with filing a lawsuit to try and fight this contract, Kempner Water Supply has raised the base rate from \$62.50 to \$67.50 per month effective April 1, 2017. We were notified of these changes around February of 2017 and were not given time to prepare a proper response before they went into effect. These rate increases are completely unacceptable and won't be stood for.

We, the members, politely request that the Public Utility Commission step in and review the contract between Lampasas and Kempner Water Supply and review the rates that we have been subjected to.

of drinking water distributed through 343 miles of water lines. Peak day production of 5.78 million gallons occurred on August 5<sup>th</sup>. Kempner's modern microfiltration plant on Stillhouse Hollow Lake produced 906 million gallons of high quality drinking water last year. Peak production occurred on July 1 of 4.56 million gallons, or 67.5% of the plant's total capacity of 7.08 million gallons per day.

Kempner recently began construction of USDA-funded project to significantly reduce trihalomethanes (TTHMs) formed during the treatment process at the microfiltration water treatment plant. This project should be complete before summer of 2017, and will usher in a new era of enhanced water quality. The improvements to the plant will reduce TTHMs to well below allowable levels, placing Kempner in a great position to significantly exceed TTHM requirements.

## Legal Update

Rates in Lampasas Contract:

The City filed suit against KWSC concerning billing under water supply agreement and seeks to recover its attorneys' fees. KWSC is defending the suit and filed a counter claim seeking declaratory judgement supporting the manner in which KWSC has billed the City and to recover attorneys' fees. The board of directors continues its efforts to reduce the subsidy to Lampasas. On March 9, 2016 Kempner filed a petition with the PUCT requesting that it find that certain provisions of the contract between Kempner and Lampasas are contrary to the public interest and should be set aside. Lampasas challenged the jurisdiction of the petition, but on September 22, 2016, the PUCT determined that it had jurisdiction over the petition. However further action on the petition by PUCT is abated while litigation remains pending.

**General Manager Comments:** *KWSC continues to resist in the court of law the subsidizing from KWSC members to the City for wholesale water. The City has refused to negotiate fairly and chooses to ignore their moral compass in regards to do the right thing by KWSC members. They know KWSC members are subsidizing for their purchase of wholesale water. KWSC has attempted to come to a resolution outside of the courts. The cost to our members, this past fiscal year, for the financial benefit of Lampasas, was \$633,912.00, while Lampasas only paid \$383,160.00 for their purchase of wholesale water. They have taken advantage of KWSC by not cooperating in resolving the subsidy, you the customer pay for their purchase of water. This will more than likely continue until another agreement is reached. This is a huge cost for KWSC to absorb.*
