
After reviewing the maps attached to the

Frognot Water Supply Corporation (WSC) has filed an application with the Public Utility Commission of Texas to amend its Certificate of Convenience and Necessity for CCN No. 10164 for the provision of retail water utility service in Collin, Hunt, and Fannin Counties. Frognot WSC is also requesting to transfer existing customers and facilities from the North Farmersville Water Supply Corporation, and for dual certification in certain areas with North Farmersville Water Supply Corporation, Caddo Basin Special Utility District, and West Leonard Water Supply Corporation.

The requested area is comprised of two areas (northern and southern).

The northern area is located approximately 3 miles north of downtown Blue Ridge, Texas, and is generally bounded on the north by Fannin CR 5005; on the east by Fannin CR 5005; on the south by the Collin/Fannin County Line; and on the west by the Collin/Fannin County Line.

The southern area is located approximately 5 mile(s) north of downtown Farmersville, Texas, and is generally bounded on the north by Collin CR 618; on the east by Collin CR 703; on the south by Collin CR 617; and on the west by SH 78.

The sale is scheduled to take place as approved by the Commission (V.T.C.A., Water Code § 13.301). The transaction and the transfer of customers and facilities includes the following area: southern, as described above.

This transaction will have the following effect on the 11 current customers' rates and services: Customers will be charged different rates than they were charged before the transaction.

The total requested area includes approximately 1,330 acres.

See enclosed map showing the requested area.

You may request a public hearing. A request for a public hearing must be in writing and include: (1) your name, mailing address, and daytime telephone number; (2) the Utility's name, docket number or another recognizable reference to this application; (3) the statement, "I/we request a public hearing"; (4) a brief description of how you or the persons you represent, would be adversely affected by the granting of the application for a CCN; and (5) your proposed adjustment to the

application which would satisfy your concerns and cause you to withdraw your request for a hearing.

Hearing requests, comments or requests to intervene should be filed with the:

within thirty (30) days from the date of this publication or notice. A public hearing will be held only if a legally sufficient hearing request is received or if the Commission on its own motion requests a hearing. Only those individuals who submit a written request will receive notice if a hearing is scheduled.

If a valid public hearing is requested, the Commission will forward the application to the State Office of Administrative Hearings (SOAH) for a hearing. If no settlement is reached and an evidentiary hearing is held, SOAH will submit a recommendation to the Commission for final decision. An evidentiary hearing is a legal proceeding similar to a civil trial in state district court.
