METHOD USED TO ALLOCATE UTILITY CHARGES

Occupancy method: The number of occupants in the tenant's dwelling unit is divided by the total number of occupants in all dwelling units at the beginning of the month for which bills are being rendered. Number of Occupants for Ratio occupancy method: Billing Purposes Number of Occupants The number of occupants in the tenant's dwelling unit 1 1.0 is adjusted as shown in the table to the right.
