COMMISSION STAFF'S CORRECTED REQUEST FOR EXTENSION OF TIME

Comes now the Staff ("Staff") of the Public Utility Commission of Texas ("Commission"), representing the public interest, and files this Corrected Request for Extension of Time.

Staff files this version to replace the version filed on January 12, 2018, which was missing a page.

I. Background

On May 23, 2017, Union Grove Water Supply Corporation ("Union Grove" or "Applicant") filed an application ("Application") to amend its water certificate of convenience and necessity (CCN) No. 10514 in Upshur County. Union Grove seeks to add three new areas of service that total approximately 2,212 acres and include 35 current customers. Union Grove seeks to be dually-certificated with the City of East Mountain (the "City") in a portion of the new service area.

Order No. 5 instructed Staff to file a final recommendation by January 12, 2018.

II. Request for Extension of Time

Staff needs additional time to circulate the maps and certificates and obtain consent from the Applicant. Therefore, Staff requests to amend the procedural schedule.

III. Proposed Amended Procedural Schedule

Staff proposes the following amended procedural schedule:

Event	Deadline
Circulation of map and certificate to Applicant	January 16, 2019

Deadline for Applicant to file consent to map and certificate	February 1, 2018
Staff's recommendation on final disposition.	February 13, 2018
Applicant's response to Staff's recommendation on final disposition. If no response is filed, the parties shall file a joint proposed notice of approval.	February 27, 2018

IV. Conclusion

Staff respectfully requests issuance of an order consistent with the above recommendations.
